
During such session the court considered a request from Public Works for permission to reimburse Frances Wells for material and labor costs to replace fencing on her property.



SUBJECT: Fencing - County Road 84

We have received a written request (attached) from Frances Wells asking to be reimbursed for material and labor costs of refencing her property along CR 84. Ms. Wells intends to apply these funds toward the cost of constructing a new fence of her own choosing.

The amount of funds required to reimburse Ms. Wells is calculated as follows:

$$6,955 \text{ l.f.} @ \$2.24/\text{l.f.} = \$15,579.20$$

We recommend your approval as the reimbursed amount is equal to funds originally slated (out of account number 010-9001-601-7101 Road Participation Construction) for Collin County to construct this fence.
