Bobby Grounds, Data Processing (10410) from Network Support Specialist - \$42,349 annually (76/8) to Network Administrator - \$48,194 annually (15/2) effective 11/11/02. **H.R. recommends \$46,800 annually (15/1)**

Suzanne Shanks, County Court @ Law Clerks (11504) from Deputy Clerk II (currently an under fill) \$25,542 annually (72/2) to Deputy Clerk I - \$25,542 annually (72/2) effective 11/11/02.
