In the event of inconsistent or extreme terrain conditions existing, as determined by Collin County personnel, guidance will be provided to the contractor identifying the acceptable length to apply this method.

2. Contract drawing identified as Exhibit H "Pipe Fence Detail 2-7/8" O.D. (Typical Corner One Direction)" of the contract specifications is hereby changed to incorporate the following statement:

Exhibit "H" will be the fence specifications for "Typical Corner and/or Gate - One Direction **over Seven-Hundred and Fifty feet (750')**" subject to terrain conditions. In the event of inconsistent or extreme terrain conditions existing, as determined by Collin County personnel, guidance will be provided to the contractor identifying the acceptable length to apply this method.

3. All other terms and conditions remain unchanged

Except as provided herein, all terms and conditions of the contract remain in full force and effect and may only be modified in writing signed by both parties.
