Sheriff Box,

On January 29, 2009 the North Texas Auto Theft Task Force was awarded \$15,000 in overtime funds on a supplemental grant for FY09 from the Texas Automobile Burglary and Theft Prevention Authority (TABTPA).

The Collin County Interagency Agreement does not include overtime funds for Sergeant Chris Ware. We revised the Interagency Agreement to include \$1,500 in overtime funds for Sergeant Ware.

All overtime funds will be paid by the TABTPA therefore there is no change in the cash match from Collin County.
