Dear Mr. Kleinheksel,

Thank you for submitting the additional information in support of Collin County's application for a custom Supplemental Environmental Project in TCEQ enforcement docket 2009-1834-PST-E. As we discussed on the telephone this morning, the supporting information and request for exception has been reviewed and we are willing to allow the sale of the property at tax sale subsequent to cleanup, provided that a conservation easement to maintain the property in perpetuity for an environmental benefit be placed on the property prior to sale. I understand that this condition may be more restrictive than the county is interested in pursuing at this time. In light of that, I sent a separate email this morning to Brianna in the Enforcement Division to see if a second extension can be granted to allow time for you to bring the information to your council and get a decision as to whether to pursue the custom SEP or whether a pre-approved SEP would be better.
