TEEN COURT Program Status




COLLIN COUNTY Teen Court administers a county-wide program that handles the disposition of cases from the justices of the peace and other agencies in a peer-to-peer setting:

That is, teenagers pleading no contest to criminal charges (truancy, shoplifting, traffic, fighting) undergo a sentencing trial by other teenagers to decide what the proper punishment should be.





Usage by Jurisdiction


FY2010 statistics so far:




Volunteers by Commissioner Precinct






