

Dear SCA Tissue Customer (USA),

Effective Monday, February 15, 2010, SCA Tissue North America will increase pricing up to 5% on tissue, towel, napkin, wipers, soap, dispensers, and specialty products.

End User and National Account contracts will be increased in accordance with the terms and conditions of the original agreement, with select items increasing more than 5%.

Orders received by the close of business on Friday, February 12, 2010, calling for immediate shipment no later than February 28, 2010, will receive current into-stock pricing. Any orders taken February 15, 2010 and thereafter, as well as all orders shipping after February 28, 2010, will be invoiced at the new, higher prices.

New into-stock price lists showing the prices effective February 15, 2010 will be mailed during the week of January 4, 2010.

Orders placed at pre-increase prices will be limited to a one-month supply based upon the previous 12 months average purchases.

This increase is due to the continuing cost escalation experienced over the long term within the overall business.

Effective Tuesday, June 1, 2010, SCA Tissue North America will increase pricing up to 10% with certain items increasing more than 10%, on tissue, towel, napkin, wipers, soap, dispensers, and specialty products.

End User and National Account contracts will be increased in accordance with the terms and conditions of the original agreement, with certain items increasing more than 10%.

Orders received by the close of business on Monday, May 31, 2010, calling for immediate shipment no later than June 13, 2010, will receive current into-stock pricing. Any orders taken June 1, 2010 and thereafter, as well as all orders shipping after June 13, 2010, will be invoiced at the new, higher prices.

New into-stock price lists showing the prices effective June 1, 2010 will be mailed during the week of April 19, 2010.

Orders placed at pre-increase prices will be limited to a one-month supply based upon the previous 12 month average purchases.

This increase is due to the continuing cost escalation experienced over the long term within the overall business.
