1. The "Service Starting Date" as specified in Paragraph 2 of the above referenced Agreement shall hereby be changed from January 1, 2011 to April 21, 2011.
2. WeatherData shall, at the request of the Client, remove the flash flood warning as specified under "SkyGuard® Services" on Attachment A of the above referenced Agreement.
3. WeatherData shall, at the request of the Client, begin providing SkyGuard® Tornado Warnings as issued by WeatherData's meteorologists with a desired lead time of twenty (20) minutes.
4. The changes as specified herein shall be provided at no increase in the current fee.

ALL TERMS AND CONDITIONS OF THE ABOVE REFERENCED ORIGINAL AGREEMENT(S) SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT WITH THE EXCEPTION OF THE SPECIFIC CHANGES, AND/OR THE ADDITIONS CONTAINED IN THIS ADDENDUM.

AGREEMENT TO THIS ADDENDUM SHALL OCCUR BY CLIENT UPON THE OCCURRENCE OF ANY ONE OF THE FOLLOWING EVENTS CAUSED TO HAPPEN BY CLIENT OR ANY OF ITS OFFICERS, DIRECTORS, PARTNERS, EMPLOYEES AGENTS OR REPRESENTATIVES: (A) PROPER EXECUTION OF THIS AGREEMENT BY CLIENT; (B) ACCEPTANCE OR ACCESS OF THE SERVICE HEREUNDER OR ANY PART THEREOF; OR (C) ACCESS OF THE SERVICE AFTER THE EXPIRATION OF ANY STATED TRIAL PERIOD, WHICHEVER FIRST OCCURS. AGREEMENT TO THIS ADDENDUM BY WEATHERDATA SERVICES, INC. SHALL OCCUR, AT ITS ELECTION, UPON THE OCCURRENCE OF ANY OF THE THREE EVENTS MENTIONED IN THE SENTENCE IMMEDIATELY PRECEDING OR UPON THE SIGNING OF THIS AGREEMENT BY WEATHERDATA SERVICES, INC. NO PERSON HAS THE AUTHORITY TO MAKE REPRESENTATIONS OR WARRANTIES ON BEHALF OF WEATHERDATA SERVICES, INC. OR TO BIND WEATHERDATA SERVICES, INC. IN ANY MANNER EXCEPT AS PROVIDED FOR IN THIS AGREEMENT.

THE CLIENT ACKNOWLEDGES THAT CLIENT HAS READ AND UNDERSTANDS THIS AGREEMENT AND HAS HAD THE OPPORTUNITY TO HAVE IT REVIEWED BY LEGAL COUNSEL AND TO DISCUSS IT WITH AUTHORIZED REPRESENTATIVES OF WEATHERDATA SERVICES, INC. THEREFORE, IT SHALL NOT BE CONSTRUED MORE STRICTLY AGAINST ONE PARTY THAN THE OTHER AND THE MEANINGS AND PURPOSES ATTACHED TO ITS VARIOUS PROVISIONS SHALL BE THOSE INTENDED BY WEATHERDATA SERVICES, INC.

THE PARTIES, INTENDING TO BE LEGALLY BOUND, HAVE EXECUTED THIS AGREEMENT. THE SIGNERS REPRESENT THAT THEY HAVE FULL AUTHORITY TO EXECUTE THIS AGREEMENT ON BEHALF OF WEATHERDATA SERVICES, INC. AND CLIENT RESPECTIVELY AND TO LEGALLY BIND SAME AND THAT THEY HAVE READ AND UNDERSTAND THE IMPORTANT SERVICE TERMS AND CONDITIONS HEREOF AND CLIENT REPRESENTS ALL INFORMATION SPECIFIED HEREIN REGARDING CLIENT IS TRUE AND CORRECT.
