If Collin County would like to receive CERT equipment purchased with 2008 SHSP sweep funds, please let me know. Your county was eligible for funding in 2008 and may therefore receive the supplies. We will transfer the consumables to you, for your use at your discretion. I understand you may have use for approximately 20 CERT backpacks, with supplies, 2 CERT instructor manuals and 20 CERT manuals. Please let me know if you wish to move forward with this transfer. Supplies have been ordered and are expected to arrive within 2 weeks. I will be on vacation until May 31, but if supplies are needed prior to that time I will make arrangements for the transfer. You will need to sign a consumable transfer form (standard for all CERT supplies). Consumables do not have to be tracked after transfer.
