Approval is granted for Collin County Health Care Services, WIC Local Agency #071, to purchase the following items for the Collin County Health Care Services Auditor's office.


- 2 Hemopoint H2 Meters G3000-Conteuv from Stanbio Laboratory with total costs not to exceed \$1,050.00.
