**Price Quote for Inmate Medical Services for Collin County**  
Effective *October 1, 2012 to September 30, 2013*

Correctional Healthcare Companies (CHC) will continue providing professional healthcare services for Collin County in accordance with the contract executed on October 1, 2008. Please refer to the contract and subsequent amendments for complete scope of staffing and services provided.

CHC submits the following Cost Proposal to Collin County for the renewal period, incorporating all services that will continue to be provided to the County:

- \$323,966.26 per month (Current Cost)
- \* 3% increase
- = \$333,685.25 per month (Renewal Cost) OR
- = \$311,782.39 per month (Renewal Cost for the Adult and Minimum Security Facilities)
- = \$ 21,902.86 per month (Renewal Cost for Juvenile Facility)
- = \$4,004,223.00 annually

For professional health care services rendered to Collin County, CHC will charge \$311,782.39 per month for the adult and minimum security facilities and \$21,902.86 per month for the juvenile facility from October 1, 2012 through September 30, 2013. All terms of the current Agreement, including any changes detailed above, shall remain in full force and effect through September 30, 2013.

**The terms of this price quote shall expire July 31, 2012, if not accepted prior to that date by Collin County.**
