


**AMENDMENT NO. 7 ("Amendment 7")
TO TECHSHARE RESOURCE SHARING ADDENDUM
COMMON INTEGRATED JUSTICE SYSTEM (CIJS) COURT ADMINISTRATION
SYSTEM**

The Parties hereby amend the TECHSHARE RESOURCE SHARING ADDENDUM ("Addendum") for the Common Integrated Justice System ("CIJS") Court Administration System that was approved by the County of Collin, Texas ("Collin County") and became effective on March 1, 2006 as follows:

- 1) Attachment A of the Addendum is amended by replacing the "Anticipated Payments to Texas Conference of Urban Counties in Fiscal Year 2012" with the revised attached "Anticipated Payments to Texas Conference of Urban Counties in Fiscal Year 2012."
