During such session the court considered adoption of the following Resolution Against Medicaid Expansion Under the Patient Protection and Affordable Care Act.

**WHEREAS**, the Collin County Commissioners Court represents the interests of all who live and work in Collin County, advocating for and protecting these constituents' general welfare and well-being; and

**WHEREAS**, the Patient Protection and Affordable Care Act (PPACA) neither protects nor is affordable for the citizens of Texas, but rather is the irresponsible expansion of a federal welfare state; and




**NOW THEREFORE BE IT RESOLVED THAT THE COLLIN COUNTY COMMISSIONERS COURT:**


