**Amendment Summary**

The Department of State Health Services (DSHS) and Collin County (Contractor) agree to amend Contract 2015-001267 in accordance with this Amendment 02: Public Health Emergency Preparedness (PHEP)

**Amendment effective date:** 04/30/2015

**Purpose for the amendment:**

This amendment is to end the contract on June 30, 2015 in order to align with the CDC fiscal year and reduce the contract amount from \$538,709 to \$458,104.

The contract date in the Statement of Work will change from "TERM: 09-01-2014 THRU: 08-31-2015" to "TERM: 09-01-2014 THRU: 06-30-2015."

The Section VIII. Special Provisions B. General Provisions, Funding Article III, Use of Funds Section 3.03 will have the July-August portion of the funding allocation removed.

The Section VIII. Special Provisions E. General Provisions, General Business Operations of Contractor Article XIV, Equipment Purchases (Including Controlled Assets, Section 14.20 will change from August 31, 2015 to June 30, 2015 and reduce the received date from 60 days to 45 days.


