Amendment No. 2

1. Each of the undersigned counties and the Texas Juvenile Justice Department ("TJJD") is a signatory to the Interlocal Agreement For Participation In The Texas Conference of Urban Counties TechShare Program ("ILA").
2. Pursuant to the ILA, the undersigned counties, the TJJD, and the Texas Conference of Urban Counties ("Urban Counties") entered into the TechShare.Juvenile and Juvenile Case Management System – Basic 2013 Resource Sharing Addendum (the "Addendum") with a term of January 1, 2014 through August 31, 2015.
3. Because the Work Plan, Budget, and Cost Allocation (Attachment C of the Addendum) is an annual document for each calendar year, there is a need to replace the work plan, budget, and cost allocation annually.
4. Amendment No. 1 to the Addendum replaced the 2013 Work Plan, Budget, and Cost Allocation with 2014 Work Plan, Budget, and Cost Allocation.
5. Attachment C of the Addendum – 2014 Work Plan, Budget, and Cost Allocation – is replaced in its entirety with the attached 2015 Work Plan, Budget, and Cost Allocation.
6. Except as specifically modified in this Amendment No. 2, all terms of the Addendum, as previously amended, shall remain in effect.
7. This Amendment No. 2 is effective January 1, 2015.






