3. A plan on how the promoter intends to limit attendance to the number of persons listed above
4. The name & address of each performer who has agreed to appear at the event and name and addresses of their agent
5. A description of each agreement between the promoter and performer
6. A description of each step the promoter has taken to ensure that minimum standards of sanitation and health will be maintained during the event
7. A description and written plan for traffic control, to control ingress and egress, to ensure the physical safety of the persons attending the event.
8. A description and written plan to provide adequate emergency medical care for those attending the event
9. A description and written plan on the supervision of minors who may attend the event.

1. Please see attached document for financial statement from promoter (Color Fun Fest).
2. Please see attached contract.
3. The limitations for attendance will be done through parking, in counted cars.
4. DJ Cyndicate, from Los Angeles, CA. Color Fun Fest's resident touring DJ, managed by Color Fun Fest.
5. DJ Cyndicate performs with Color Fun Fest in all events across the country.
6. Porta Potty company is in place. As the event gets closer, the attendance numbers are calculated to make sure there are enough toilets for participants - 1 toilet per 250 attendees.
7. Parking will be held in the east lots that are a combination of 6 soccer fields. The space measured indicated 23 acres. To our experience, we can fit 150 cars in 1 acre. This comes out to about 3450 parking spots available for our event. Average 3 people per car comes to 10350 capacity per run - but we won't come anywhere close to that, so we have no doubt that it will be very simple to keep all in order. Parking will be held in the east lots that are a combination of 6 soccer fields. The space measured indicated 23 acres. To our experience, we can fit 150 cars in 1 acre. This comes out to about 3450 parking spots available for our event. Average 3 people per car comes to 10350 capacity per run - but we won't come anywhere close to that, so we have no doubt that it will be very simple to keep all in order. Please see attached map.
8. EMT services will be on site for the duration of the entire event. Event supervisors will be in contact for any incidents that may occur, for swift and proper care to be taken care of. If any persons need to be transported off of the property, an ambulance will be called for transport.
9. All minors must be accompanied by an adult.

**Additional Relevant Event Information:

The event will not be serving alcohol.

Though there may be up to 10,000 people, they will not all be there at once. There will be about 3k - 5k per wave.

We will have two separate 5K runs. One will be held at 3:00 PM and the other at 8:00 PM. The full schedule is as follows:

1:00 PM - Doors Open

3:00 PM - Day Run

8:00 PM - Night Run

10:00 PM - Event Ends
