



Notice is hereby given of a joint public hearing to be held on behalf of the The Industrial Development Authority of La Paz County, Arizona on March 21, 2016, at 10:30 a.m., at Andrews Kurth LLP, 1717 Main Street, Suite 3700, Dallas, Texas 75201, with respect to the captioned bonds (the "Bonds") to be issued in an aggregate principal amount not to exceed \$60,000,000 by the Industrial Development Authority of La Paz County, Arizona (the "Corporation"). The proceeds of the Bonds will be issued as part of a plan of finance and loaned to Charter School Solutions, a Texas nonprofit corporation (the "Borrower") for the following purposes:

- (1) The purchase of land school sites and the construction, equipment and improvement of charter school facilities of the following locations:
  - (a) North of Mapleshade Ln., west of Colt Rd., and east of Ohio Dr., Plano, Texas 75075;
  - (b) 9345 Beraj Dr, El Paso, Texas 79907;
  - (c) 701 S. Industrial Blvd., Euless, Texas 76040;
  - (d) 13201 Lomas Blvd NE, Albuquerque, NM 87112;
  - (e) 4611 S. Carrier Parkway, Grand Prairie, Texas 75052
  - (f) Eldridge Road, South of W. Airport Blvd., Supar Land, Texas 77479
- (2) Paying capitalized interest;
- (3) Funding a reserve fund; and
- (4) Paying the costs of issuing the Bonds.

The Project will be owned and operated by the Borrower. The Bonds are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.
