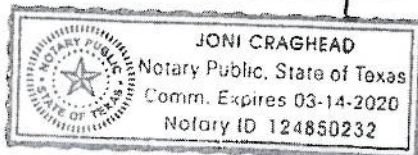

- (b) paying the costs of issuing the Bonds.

The educational facilities will be owned and operated by the Borrower. The Bonds are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

The public hearing will be conducted by John Kapler Esq., or his designee (the "Hearing Officer"). All interested persons are invited to attend such public hearing to express their views with respect to the above-described project and the Bonds. **APPLICATION AND PRELIMINARY DECISION.** City of Celina, 142 North Ohio Street, Celina, Texas 75009, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0014246001, which authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 950,000 gallons per day. TCEQ received this application on December 14, 2015.

The facility is located at 700 North Florida Drive, Celina, in Collin County, Texas 75009. The treated effluent is discharged to an unnamed tributary, thence to Little Elm Creek; thence to Lewisville Lake in Segment No. 0823 of the Trinity River Basin. The unclassified receiving water uses are high aquatic life use for the unnamed tributary and intermediate aquatic life use for Little Elm Creek. The designated uses for Segment No. 0823 are high aquatic life use, public water supply, and primary contact recreation. All determinations are preliminary and subject to additional review and/or revisions.
