struggling with the issues in the 900 Building, but the Trustee does not want to lock in the lower rate for another three years.

Candy Blair, Heath Care Services, said she would have to seek preapproval from the state for the rate increase. She does not foresee a problem with a rate increase, but did ask for it to be held off until Veteran's Affairs is out of the WIC space.
