

DESCRIPTION

STATE OF TEXAS COUNTY OF COLLIN

BEING all that tract of land in Collin County, Texas, a part of the Abner Lee Survey, A-516, and being all of that called 160 acre tract of land described as the Third Tract conveyed to O. C. McDearman, Jr. and wife Jessielea McDearman And Guy C. Setliff, Jr. and wife Flora Lee Setliff from A. Wayne Light and wife Edna May Light on April 5, 1968 and being further described as follows:

BEGINNING at the Northeast corner of said tract, a 3" steel rod set for corner;

THENCE South, 1859.20 feet to the Southeast corner of said tract, a 1" steel rod found for corner;

THENCE West, 3170.22 feet to a 2" steel rod set for corner;

THENCE North, 459.10 feet to a ½" steel rod set for corner;

THENCE North 89 degrees 02 minutes 27 seconds West, 562.28 feet to corner in the center of a county road, a 1" iron pipe bears South 89 degrees 02 minutes 27 seconds East, 20.00 feet for witness;

THENCE North 01 degrees 06 minutes 03 seconds East, 1563.35 feet along the center of said road to corner, a ½" steel rod bears North 89 degrees 24 minutes 41 seconds East, 20.00 feet for witness;

THENCE North 89 degrees 24 minutes 41 seconds East, 1706.72 feet to a ½" steel rod set for corner;

THENCE South, 187.00 feet to an iron stake found for corner;

THENCE South 89 degrees 55 minutes East, 1995.77 feet to the point of beginning, containing 160.062 acres of land of which 0.718 acres lie within said county road, leaving a net of 159.344 acres of land.
