GENERAL DISCUSSION

5. Al-44190 Substance Abuse Update, LifePath Systems.

Randy Routon, Ph.D. & CEO of LifePath Systems, came forward to brief the Court on the Substance Abuse System for Collin County. In 2016 the Sunset Commission recommended a change from NorthSTAR. Some of the issues with NorthSTAR were: 1) problems with the distribution of funds; 2) Medicaid dollars being spent for indigent clients; 3) mental health dollars being spent for substance abuse clients; and 4) questionable outcomes. During the transition from NorthSTAR, the State asked LifePath to pilot the Substance Abuse Authority. The County and State agreement separated Medicaid and indigent dollars.

The role of the Authority includes building a provider network, resource allocation, areawide strategic planning and coordination, resource development, compliance with HHS (Health and Human Services) regulations and contract, approving provider billings and community education and prevention. However, substance abuse funding is not enough to fund the needs here or across the State.

The second role of the Authority is OSAR (Outreach, Screening, Assessment and Referral). OSAR functions are conducting quarterly meetings of stakeholders, maintaining the substance abuse resource directory, screening potential clients for financial eligibility, assessing needed levels of treatment, providing brief intervention and screening for diseases transmitted through needle use such as HIV and Hepatitis.

Dr. Routon said there is funding for 116 clients for opioid treatments. In the transition from NorthSTAR, LifePath took on 158 clients requiring opioid treatment, and that number has gone down to 141. They are making sure that everyone in the system meets the criteria to be considered indigent. A report from the White House states the opioid crisis cost the US economy \$504 billion in 2015. There were 33,000 opioid-related deaths with 2.4 million US citizens addicted. It is estimated that over 70% began with legal prescriptions for painkillers. The State has designated money to go directly to opioid addiction services. For LifePath, this meant rationing available dollars for other things.

Some of the current challenges in Substance Abuse Services are low funding for a known need, limited providers, and the current providers are unfamiliar with the State's complex system. LifePath's approach has been to ensure accurate documentation and to stretch the funds as much as possible. There are four grants in now. One is SB292 which is a collaboration between LifePath and the Sheriff's Office to get more hospital bed days for people in jail but who really need treatment. Another is HB13 which would allow LifePath to select the biggest gap in the community - substance abuse - and ask for dollars to serve that need. There are two other grants related to mental health. The State has asked the County to match the funds it receives from the State. Dr. Routon thanked the Court for its support on this.

Commissioner Williams said there are providers that have said it was easier to get treatment before the transition to LifePath. It is important to point out that Medicaid dollars were being used to treat indigent individuals which is not allowed. One of the main reasons for leaving NorthSTAR is this was illegal activity that would put the Medicaid dollars from the state at risk. The Commissioner also asked if the Substance Abuse Authority is an annual contract with the State. Dr. Routon confirmed that it was. Commissioner Williams said the State did come up with additional dollars but only for one year. They did not include them in the last legislative session, and we may need to decide if we want to continue to be the authority without the funding. (Time: 6:30 p.m.)

Caren Skipworth, CIO, came forward to update the Court on the Elastic Search tool used in IT for Collin County applications. In FY2016, the IT Department was looking at search engines to see if the County would benefit with the use of a search engine. At that time, Elastic was brought in as a freeware. The IT Department worked with Stacey Kemp, County Clerk, and delivered Ms. Kemp's foreclosure product using the freeware and deemed that it was an excellent product for the County to bring in as a standard application development tool for IT. Elastic is easy to use, fast, the public likes it, and it is CJIS (Criminal Justice Information Services) compliant. Between January 2017 and October 2017, there have been 420,028 pageviews which equates to 1,400 per day.

Elastic has the ability to index and search almost any kind of data; allows access to real time analytics information about the data it collects; and gives developers a simple platform to create applications that search and display the data. Elastic is in real time, so there is no batch processing. Elastic is not an end-user tool; it requires development and programmers. Collin County vendors that use Elastic include Tyler Technologies, Cisco, Oracle, PeopleSoft and Microsoft.

Some of the future Elastic projects include Open Records Requests, AS/400 old data, one-stop-shop for property in Collin County, an integrated search of our external website, Constable and Sheriff Sale notices and possible Homeland Security Data Warehouse alternative. Commissioner Thomas said when the department heads and elected officials see the capability of this tool, the sky is the limit. (Time: 7:25 p.m.)
