Sheriff Jim Skinner came forward to present Life Saving Awards to three people who have made a difference in the lives of others. The first award was presented to a civilian, Denise Chavira, a respiratory therapist, who performed CPR on a drowning four-year-old child at a Trinity Falls pool. Because of Ms. Chavira's quick and selfless actions, the child made a full recovery and suffered no brain damage.

Sheriff Skinner then presented Deputy Sheriffs Jonathan McCann and Max Picco with Life Saving Awards. After responding to an incident and making an arrest, Deputy McCann was transporting the subject to the Sheriff's Office when he noticed the man was slumped over in the back seat. Deputy McCann pulled off the road and checked the subject who was foaming at the mouth and unresponsive. Deputy Picco pulled up behind Deputy McCann, and together they removed the subject from the vehicle, un-cuffed him and started CPR. They were able to revive the subject twice by the time an ambulance arrived to take him to the hospital. He is alive today because of these two deputies. Sheriff Skinner expressed his gratitude and said they are there to protect and serve and that is just what they did. (Time: 1:37 p.m.)

## **GENERAL DISCUSSION**

A motion was made to split the Court's votes among the incumbents. Commissioner Williams commented that the Court does not have enough votes to appoint an individual to the Board. Judge Self said votes are proportional to the amount of taxes collected. Therefore, the Board of Directors is primarily controlled by the school districts and then by the cities. (Time: 1:41 p.m.)

7. Al-33858 RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the latest RTC (Regional Transportation Council) meeting. The first item of interest was the RTC approved reprogramming of transit funds to support several projects at DART (Dallas Area Rapid Transit), the DCTA (Denton County Transportation Authority), and the FWTA (Fort Worth Transportation Authority).

Another item was regarding moving monies allocated to Collin County into Category 12. As of last week, those funds have been moved back into Categories 2 and 4. Most of this is for congestion mitigation which the Texas Transportation Commission is supporting. Therefore, Collin County's dollars are not as much at risk as they were last month.

The next item of interest was the Alternative Fuel Corridors. The federal government has been asking that corridors be identified throughout the United States for different alternative fuels such as electric vehicle charging, hydrogen, propane and natural gas. The RTC has proposed that US75 be put on the list. Given the amount of freight that goes along US75, the Commissioner thinks it will be approved. There would be incentives for putting electric charging stations and other alternative fuel stations along the corridor.

Judge Self said the cities wanted US75 to remain a commuter highway and suggested the Commissioner talk to the cities to make sure they are aware of this since it will more than likely encourage more freight traffic on US75. Commissioner Webb said the city representatives at the meeting had no negative comments.

Another item was regarding low-speed automated vehicles. A study showed that 60% of people under the age of 45 will purchase an automated vehicle.

The Mobility 2045 Plan continues and public meetings will start in January 2018. The submission deadline is November 17, 2017.

The last item was regarding CMAQ (Congestion Mitigation and Air Quality Improvement Program) and swapping. If there are local projects that are complying with the federal environmental regulations, you could go to COG (Council of Governments) and RTC to swap and pick up an extra \$2 or \$3 for each local dollar submitted.
