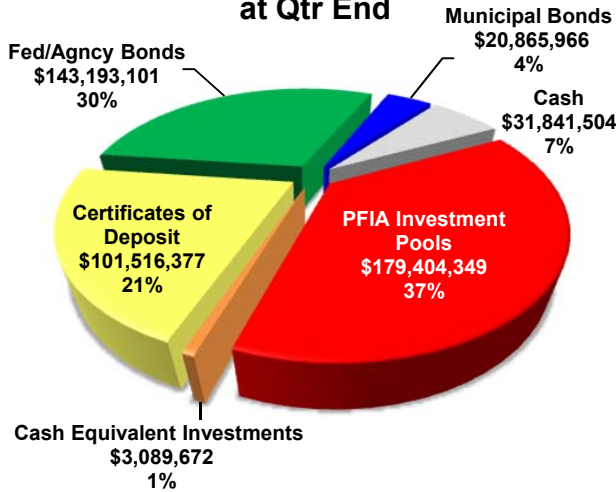

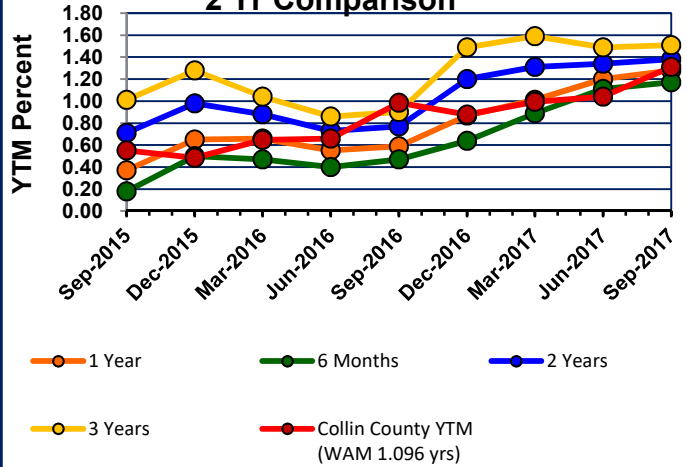

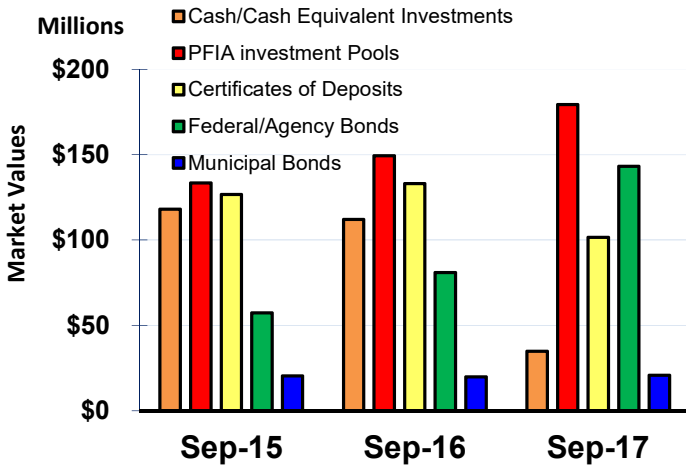
**Portfolio Composition by Type at Qtr End**



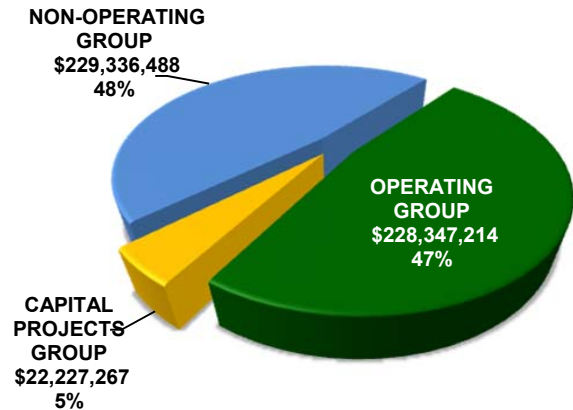
**US Treasury Benchmarks 2 Yr Comparison**



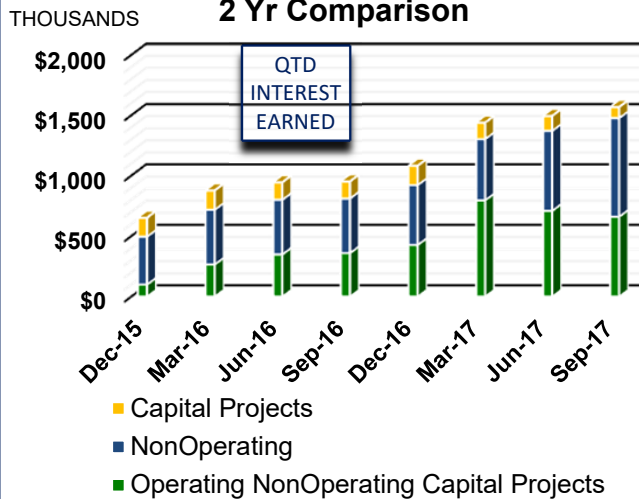
**Portfolio Position by Type 3 Yr Comparison**



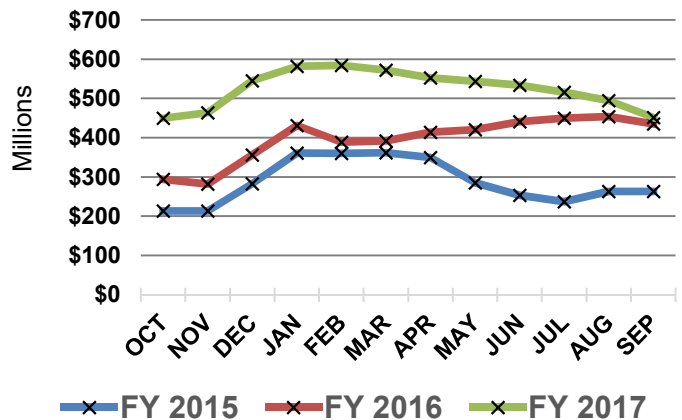
**Portfolio Composition by Investment Pool Group at Qtr End**

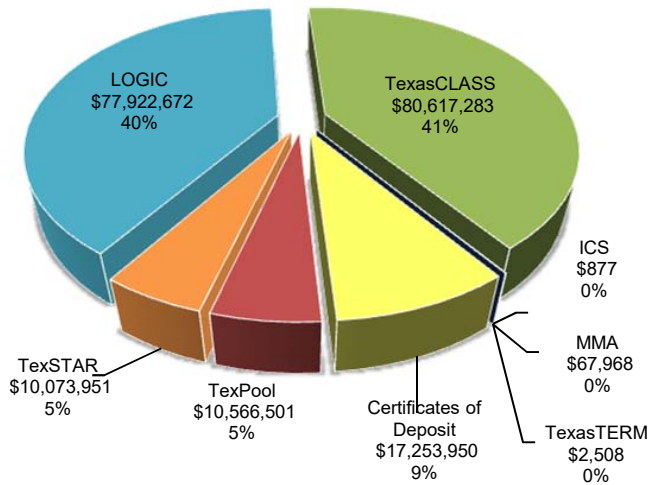

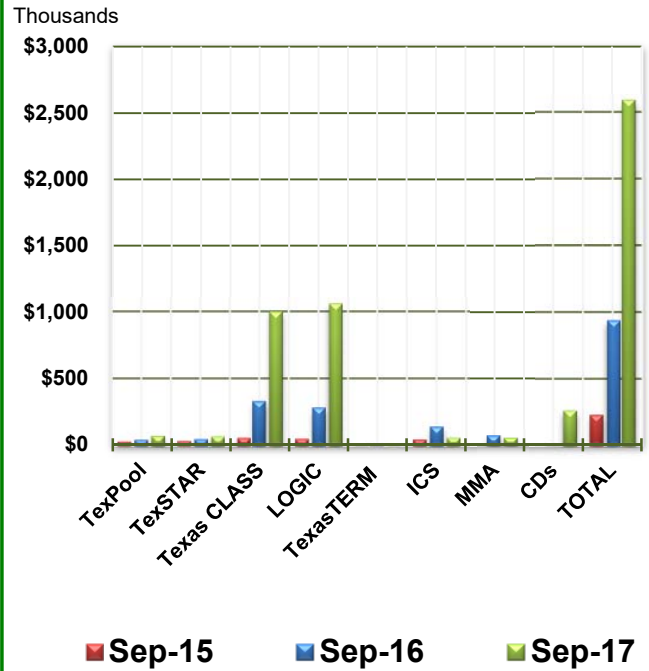

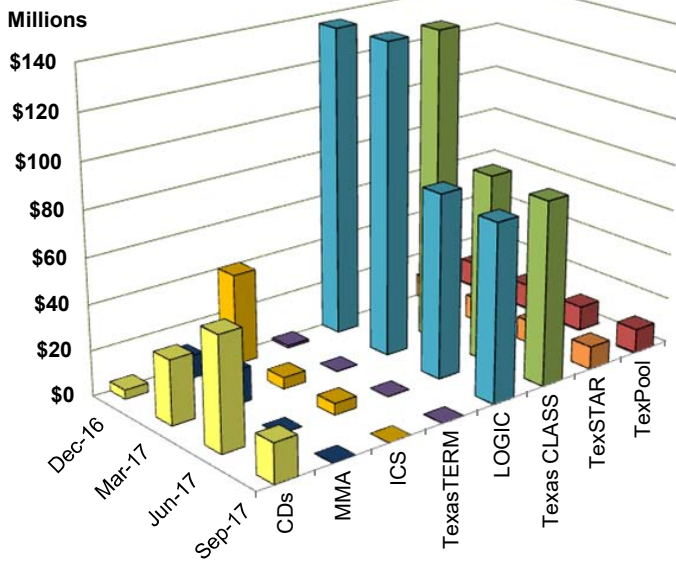
**Operating Investments by Type at Quarter End**



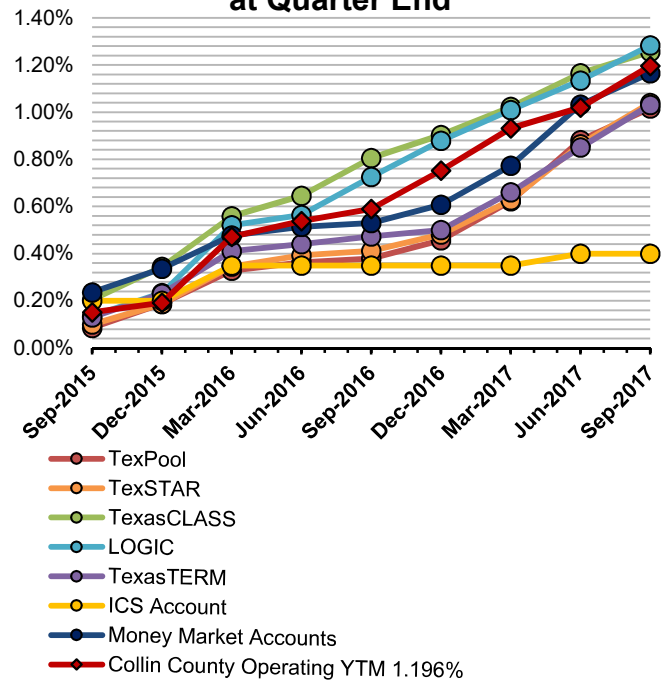
**Operating Investments YTD Interest Earnings Comparison at Quarter End**

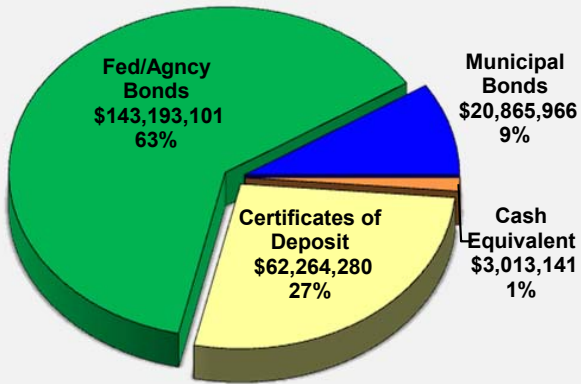




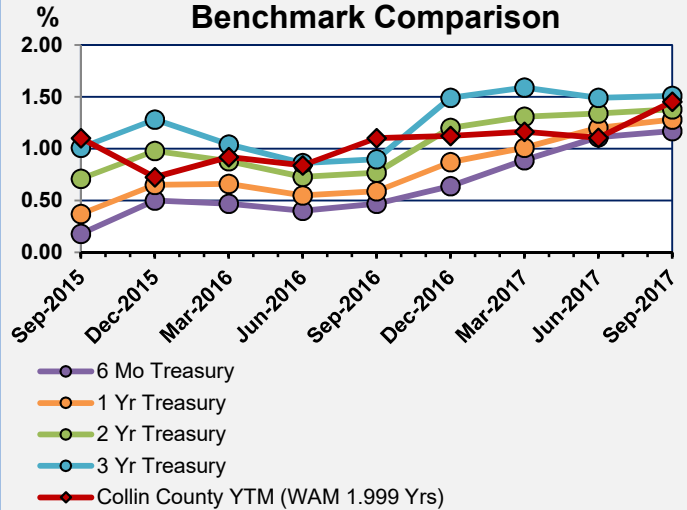

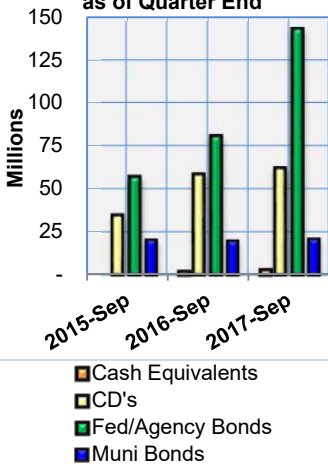
**Non-Operating Investments by Type at Quarter End**



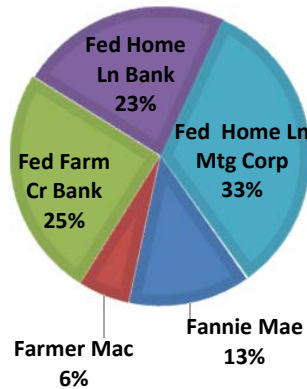
**Non-Operating Yields to Maturity Benchmark Comparison**



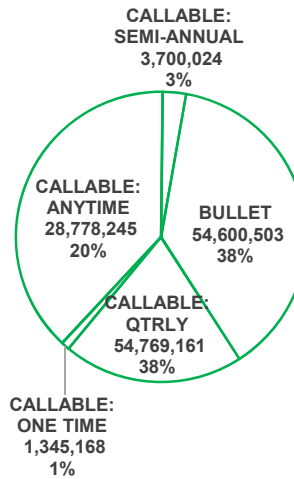
**Non-Operating Investments Three Year Comparison as of Quarter End**



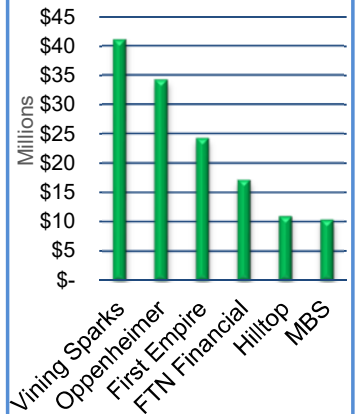
**Federal Agency Bonds Breakdown by Issuer**



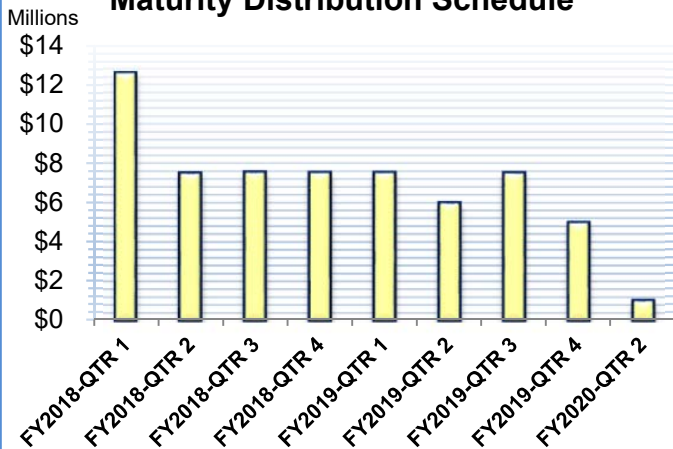
**Fed Agency Bonds Breakdown by Type**



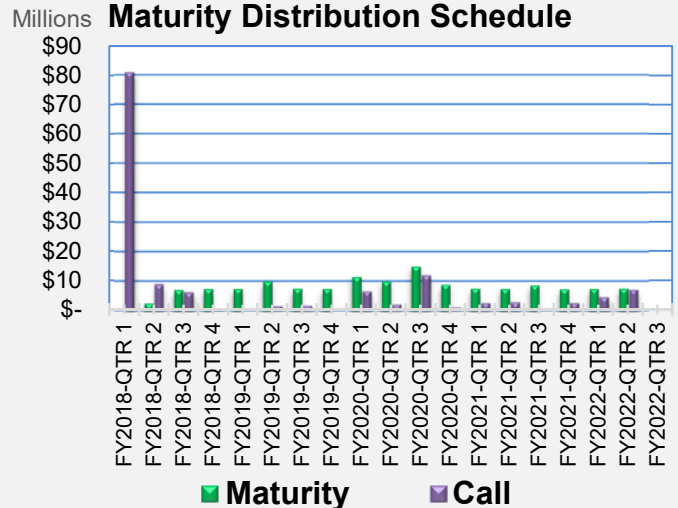
**Federal Agency Bonds Breakdown by Current Broker/Dealer**

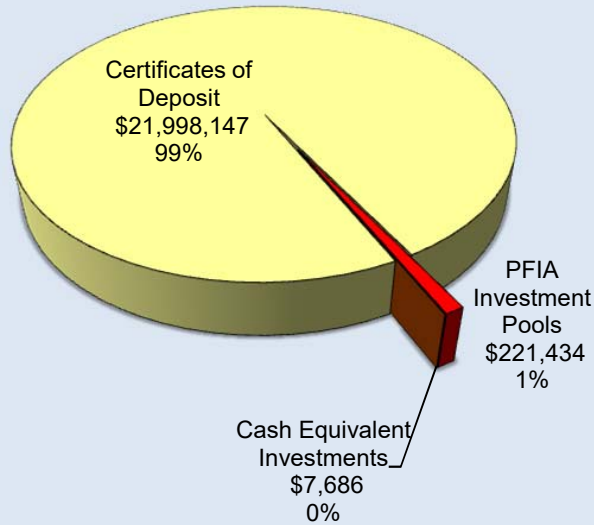

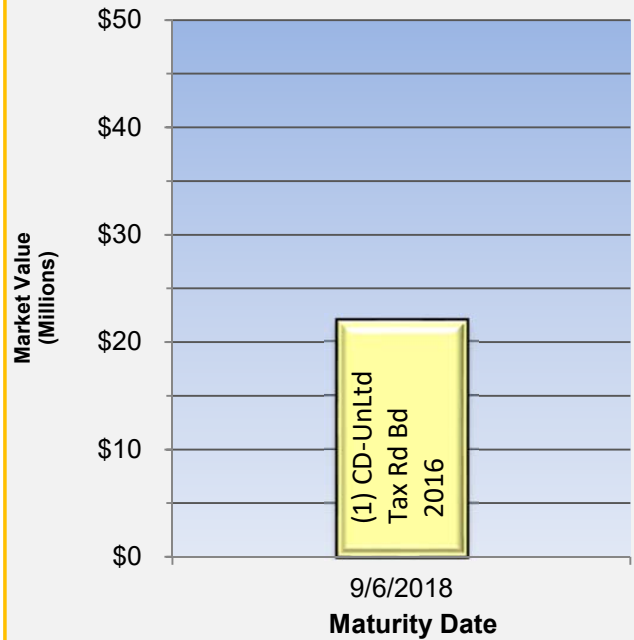

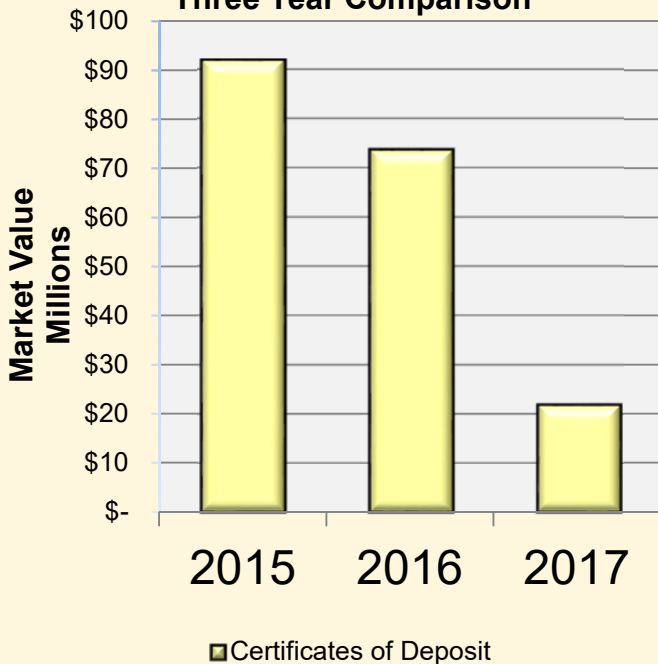
**Capital Projects Investments by Type at Quarter End**



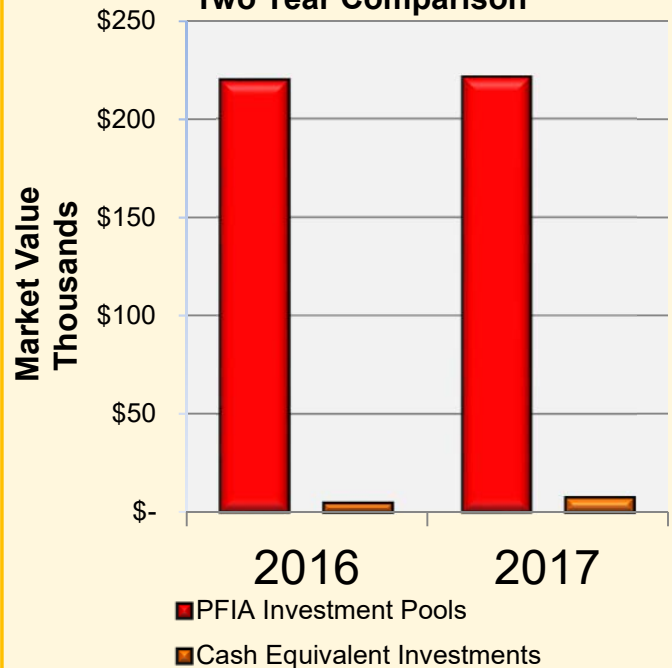
**Capital Projects Investments Certificates of Deposit Maturity Distribution Schedule**
