1. President Self called to order the meeting of the <u>Collin County Housing Finance</u> <u>Corporation</u> at 5:05 p.m.

GENERAL DISCUSSION

2. Presentation by First Life Planning for affordable housing project for adults with learning disabilities, Administrative Services.

Randy Routon, Ph.D. & CEO of LifePath Systems, introduced David DeBowsky, President of 1st Life Planning, an established non-profit to provide housing solutions that will serve adults with special needs. Dr. Routon said it is getting more difficult to find affordable housing due to the population growth within the County. 1st Life Planning is working to enable providers like LifePath to place people with severe disabilities in affordable housing. 1st Life Planning will provide the capital investment for the properties, make sure they are ADA (Americans with Disabilities Act) compliant, and maintain the properties. The providers are responsible for staffing and keeping the standard of care for the IDD (Intellectual and Developmental Disabilities) individuals in the homes.

The mission of 1st Life Planning is to continue to put more and more homes on the ground. The requested \$140,000 grant from the Collin County Housing Finance Corporation will be used to purchase at least two four-bedroom homes within Collin County. The difference between the cost of the homes and the grant will be provided by 1st Life Planning. There will be between four and six individuals living in the homes. The nonprofit will own title to the houses, and the tax exemption on the property will enable them to keep costs down. Mr. DeBowsky explained there is a "poison pill" in the non-profit's charter preventing anyone from trying to change the mission and make it for-profit.
