On the unit being replaced, the mainframe, hydraulic system, and joysticks will be repurposed saving the County \$27,000. With no further discussion, a motion was made to approve the item. Judge Self said the City of Anna is one of the partners in this program, and they will benefit from the use of the P25 Public-Safety Radio System. The County has given the city an engineering solution for their water tower. However, the city is not comfortable with this and would like to do their own engineering. Major Pam Palmisano, Sheriff's Office, said they are not comfortable with the engineering study because they don't have anyone qualified to understand it and want to make sure the County does not mount anything that would harm their new tower. The Judge said the study was done by an engineering firm that is familiar with placing this equipment on water towers. Kelley Stone, Chief Deputy, said this is under the supervision of the Public Works Director who is responsible for that tower. They are asking for a maximum of \$2,500 for an engineering study. There was a brief conversation regarding the two unsigned ILAs with the City of Anna.

Commissioner Williams suggested holding this item and continuing discussions with the City of Anna. The County has invested \$10.7 million in the project with \$14 million total budgeted for this. Major Palmisano said the radio project has already been delayed. At this point they will not be on the air until July, and then there will be three months of testing. Motorola could penalize the County by sending the tower crews back to where they came from. If they then have to redeploy the tower crews, that cost comes back to the County. Commissioner Fletcher does not want to pay for a redundant answer from another engineering firm. No motion was made to approve the item. (Time: 1:42 p.m.)
