Bill Bilyeu, County Administrator, said the state put out a call for state funding in December 2017 for grants to non-profits or government entities that are not the LBHA (Local Behavioral Health Authority). In order for the applications to be submitted to the state they need to have the backing of the LBHA and the county. In this case the application is on behalf of the County. The Court is being asked to approve the submission of the grant which includes the approval of the application and letter of support for the program. The state will make decisions in June on the two-year grants.

Alyce Ferguson, Indigent Defense Managed Counsel, said this is a great opportunity to address the ongoing need of linking the County's high-needs people with services. A strategic plan was developed by the state on gaps missing in treating these special populations: veterans; substance use disorders; mental health and intellectual developmental disabilities; and the jail population. One of the unintended consequences of the last legislative session is that people are getting out of jail so quickly they're not getting linked with services. Ms. Ferguson wants to be able to fill those gaps.

She proposed putting in place a coordinated release discharge planner/case manager for the jail. This position would be much like the discharge planner for the mental health bonds which has had great success. If implemented at the jail level it will reach the people who wouldn't normally be routed through her office because they are not in jail long enough. By doing this it will ensure they are handed off to LifePath or to another agency to provide services.

She said the Sheriff's Office has agreed to provide a workspace for the position. The total budget cost requested would be \$104,927. The County must provide a match to the state funds which is \$52,463. Part of that would be matched in-kind bringing the cash match for the County to \$31,601.

Judge Self said the reason why we tried to get the LBHA is to make sure people don't fall through the cracks and this is a perfect attempt to do that. Commissioner Williams agreed and said if the County is going to ask the state to beef up their contributions to Collin County, then the County is going to have to show willingness to invest in programs when opportunities arise. A motion was made to approve the submission of the grant application and letter of support. (Time: 1:43 p.m.)

Chief Deputy Kelley Stone, Sheriff's Office, said the funding request is for a fourth SCORE (Sheriff's Convicted Offender Reentry Effort) Program officer. State funding has been made available to the SO (Sheriff's Office) to continue the program. With the three current officers, there has been an average of \$128,000 per year per officer in local contributions. He said there is more work to be done in the community and it is expected to continue with great contributions to the taxpayers.

Judge Self asked why the SO is requesting another position when there are 12 open positions. Chief Deputy Stone said there is a minimum number of staffing to keep beds open and the SO does not want to fall behind in the required number of staffing by the TCJS (Texas Commission on Jail Standards). If the entire jail was open the SO would be behind in staffing. It is desired to keep the number consistent and not lose a person which is why an additional position has been requested. The Judge was fine with expanding the program, but would like the extra position addressed during budget time to avoid setting precedence and counting against the 8% which is how much the budget can grow without going to the voters.

Chief Deputy Stone said there is concern because the SCORE positions are solely based on grant funding and not permanent, so there is no expectation there will be a positon for the officers to fill when the grant ends. The officers are aware of this when they are hired/promoted from within. Judge Self asked Bill Bilyeu, County Administrator, when the last time a person was dismissed over grant funding. Mr. Bilyeu said it was three or four years ago. Chief Deputy Stone said this has already happened to the SO. A few years ago there were circumstances when a lieutenant, secretary and some other staff positions in this program went away. Those were eventually absorbed into the SO.

Commissioner Thomas said if there were 13 open positions, the intention would be to fill all 13; therefore, there wouldn't be an open position except for turnover. So the argument is not germane. The Commissioner asked how long it will take to fill the 12 open positions based on current hiring conditions. The Chief Deputy said it will take one to two months at most to fill the positions.

Commissioner Williams asked what the impact is on recidivism of inmates who participate in the SCORE Program. Yoon Kim, CSCD (Community Supervision and Corrections Department), said the program has a 90% or higher success rate. While in the program recidivism is very low. However, he has yet to see the numbers on what happens once the offender has graduated from the program and is off probation. Mr. Kim added that approval has been received from TDCJ-CJAD (Texas Department of Criminal Justice-Community Justice Assistance Division) to expand the SCORE Program. Budget adjustments have been made on the CSCD end to be able to pay for an extra detention officer and another CSCD employee for the SCORE Program.

Commissioner Williams asked what the backlog of projects looks like which the SCORE Program can be used for. Terry McCraw, Assistant Chief-Jail Administrator, listed several of the projects: cemetery restoration; lots for Habitat for Humanity; crop planting to subsidize food for the inmate population food budget; and wood chipping at the Heard Museum and the grounds north of the courthouse. Currently there are three full crews working on the projects. An additional officer would allow for another crew to work on cutting down the backlog. Judge Self said there is a position within the 12 open positions to use for the program. Commissioner Williams said it is critical to have all 12 positions for the detention center and she does not want to take one away because that is the normal turnover. Commissioner Fletcher agreed with Commissioner Williams and said there are a lot of benefits to adding a fourth SCORE officer. Jim Skinner, Sheriff, came forward to say the SO is working very hard to continue to bring down the overtime numbers and this week the overtime numbers were down. When the 12 positions are filled they need to be trained and committed to main jail housing which is where the SO is shorthanded.

Commissioner Thomas asked if these types of changes are done in the middle of a budget year or are they held off until the next budget season to prioritize with everything else. Commissioner Williams said if they are being funded out of the County's budget then they would typically wait.

In this case, it is not being funded out of the County's budget; therefore, she has no concerns on adding it midyear. Judge Self agreed, but his consideration is the major budget items coming in the new budget year which reduce the flexibility of the Court. He believes the County can handle the new contract with CSCD for the next eight months and then determine where this position falls in all the budget requirements and how close the budget will come to the 8%.
