# 2. Public Comments.

Joshua Martin, Frisco, came forward to speak on the Executive Session item regarding the protest of RFP (Request for Price) No. 2017-121 for the inmate telephone system. Mr. Martin is employed by Securus Technologies, but spoke as a resident and taxpayer of Collin County. Because of his employment with Securus he is aware of the facts underlying the bid protest. Collin County issued an RFP for inmate telephone services at the Detention Center. Securus, the incumbent provider, responded as did other companies. At the conclusion of the specified fifth and final round of scoring in the RFP process, Securus was in the lead by a comfortable margin. The County should have awarded the contract to Securus but did not. Records show that County personnel created and applied a sixth round of scoring, not specified in the RFP, which was directed only at Securus. The net result was Securus' scores were reduced by enough to award the contract to ICSolutions. The deviation from the RFP scoring specifications is sufficient grounds for the bid protest. Also, during the sixth round of scoring County personnel reached out to Williamson County, a former customer of Securus, and solicited inaccurate and negative information. In addition, County personnel retroactively reduced Securus' scores. As a Collin County taxpayer this concerns him because of: 1) integrity in public procurement; 2) Securus is the industry leader; and 3) the contract is a revenue generating contract for the County - Securus' financial offer was \$2.275 million more than ICSolutions. Mr. Martin respectfully requested the Court look closely at the bid protest and the underlying facts. (Time: 1:34 p.m.)

# **GENERAL DISCUSSION**

**5.** <u>AI-44459</u> RHP 18 DSRIP Update presented by Public Information Associates (PIA), Administrative Services.

des Anges Cruser, Ph.D., RHP (Regional Health Partnership) 18 Anchor Team, came forward to give a presentation on the changes of the DSRIP (Delivery System Reform Incentive Payment) rules and structure for the extension of DY (Demonstration Year) 7 and 8 as well as on requirements and schedules the providers and anchors must meet to continue to participate in the Medicaid Waiver Program. The Medicaid Waiver Program is meant to provide dollars for services which would otherwise not be covered under the current Medicaid rules. It also provides services for uninsured and low income individuals who would not be eligible for Medicaid.

The extension was approved December 21, 2017 and the last day to submit the RHP Plan Update is April 30, 2018. The extension is complex and complicated with many new features. DY7 and 8 will now run the calendar year rather than October through September. There are four elements in the program: the provider, the measures, the activities to achieve the measured goals, and sets of statewide reporting measures that are different according to the type of provider. Most, if not all, of the infrastructure and program components are in place. Over the last six years providers have been developing infrastructure, getting programs in place and coming up with new ways of delivering care. What hasn't changed is the way the providers are paid. The focus will no longer be on expanding or improving projects but on system-wide performance and outcomes.

There is a separate menu of measures and measure bundles by provider type with specifications for tools and methods of calculating goals and progress. Providers must use prescribed instruments and tools to measure outcomes. MPT (Minimum Point Threshold) is based on one MPT per \$500,000 valuation. For example, Texoma Medical Center has \$5 million in all four categories so they have a minimum MPT of ten. All measures of the measure protocol have points assigned; therefore, the providers have to select an adequate number of measures to meet the minimum MPT. There are aspects of the system the providers must address and report, including an emphasis on developing alternative payment models and progress on cost-savings or cost reduction overall.

Categories are now referred to as B, A and C and are all interrelated. Category B is the Provider System made up of hospital and physician practices, CMHCs (Counseling and Mental Health Center) and LHDs (Local Health Department). Each provider operates in a healthcare system that is small or large, simple or complex. Each provider must define a system first. The system includes all components of the organization that provide a service to a patient. Category C is made up of measures and measure bundles. The menu

Commissioners' Court Meeting Minutes February 26, 2018 Page 5 of 10 of measures differ by provider type: CMHCs have 48 measures; LHDs have 32 measures; and hospital and physician practices have 24 bundles with between three and eleven separate measures. Point values are assigned to measures using a formula and as stated earlier each provider has a minimum MPT. Category A is made up of core activities. There are 13 domains in the Category A menu. Providers select any number of core activities in relevant areas that they will perform to achieve the targeted outcome for a measure. Each category is allocated a percentage of the total value the provider has and HHSC (Health and Human Services Commission) has a formula to calculate the percentage.

Providers must also provide a driver diagram for each core activity selected which details the conditions or strategies that underlie the primary drivers. Following the primary drivers are the secondary drivers and change ideas. Secondary drivers are conditions or activities that underlie the core activities. Change ideas are the strategies and actions that secure the secondary drivers.

Dr. Cruser went into more detail on the Category B System which is the Provider System. There are required and optional components by provider type. For example, a hospital must have maternal care, urgent care, emergency care and general inpatient care. If they have those, they must report the people who have been seen in those components which forms the basis to better understand where the Medicaid, low-income and uninsured fall in the larger system of care. The DSRIP attributed population is the Medicaid, low-income and uninsured population. Target population is only selected by hospitals and physician practices because the CMHCs and LHDs have predefined populations. Denominator specifications may include specific visit types as part of the denominator inclusion criteria. Stratify by payer means the providers will be reporting the Medicaid, low-income and uninsured separating.

HHSC distributed two complex provider plan templates to complete and submit: the Provider Plan and the Anchor Plan. The anchor team is working one-on-one with providers to assist in completing their templates. While different rules and measure bundle menus apply to providers depending on the provider type and MPT, all providers must follow the same process and all must report on Category D. Category D is the statewide measures for which the state transmits data and the provider responds with qualitative information about what they have done to improve the healthcare of a certain population or made any impact on reducing unnecessary readmissions to a hospital. Providers also have to verify valuations and distributions across measures, assure they have IGT (Intergovernmental Transfer) access and acknowledge additional reporting requirements.

Providers with initiatives in more than one RHP could opt for one "home" RHP for reporting purposes. RHP18 has seven providers; however, Lakes Regional MHMR and UT Southwestern and Children's Health opted to work all their DSRIP programs through RHP9. They will continue to participate in the RHP18 activities such as the Learning Collaboratives. Texoma Community Center opted to work all their DSRIP programs

There are five participating providers to include in the RHP Plan update: two new providers – Helping Hands in Rockwall and A Women's Health Clinic which will be in McKinney; and three continuing providers – Centennial, LifePath Systems, and Texoma Medical Center.

Other requirements in the RHP Plan update include the Community Needs Assessment, public comment and stakeholder RHP Plan reviews, a Learning Collaborative Plan, and the creation of regional portraits for valuations, the systems, and the measures.

Future funding expectations include: \$3.1 billion each year for DY7 and DY9 statewide; DY9 funding will decrease by 6%; DY10 funding will decrease by 14% from DY9; and DY11 funding will decrease to zero in 2022. In late 2018, HHSC will work with stakeholders to determine how the reduced funding pools for DY9-10 will be distributed. As of now it is unknown how many providers will continue past the next two years.

Dr. Cruser shared a slide containing the DY7 total DSRIP funds allocations to the RHP18 providers. This included the DY7 value and the approximate IGT. The slide did not include uncompensated care dollars. The final slide showed the values in RHP18 was \$153.8 million with \$14.4 million remaining uncollected. Approximately \$12 million of the uncollected funds will be collected from carry forward metrics this year.

Commissioner Thomas asked how the money is allocated to the providers. Dr. Cruser said it is based on reporting achievement. Once the RHP Plans are submitted and approved the providers will be eligible for 20% of their value for the year.

Commissioner Williams asked if there are more opportunities for new projects with leftover dollars. Dr. Cruser has asked HHSC if another RHP doesn't use all their funds, could those funds be reallocated to a different RHP. HHSC said reallocating was not an option.

Judge Self asked if there are any results from the program thus far. Dr. Cruser said there are reports, but those are on the impact of reducing emergency room visits and reducing unnecessary hospitalization and readmissions which was the original focus of DSRIP. Results have not been population health outcome driven. It has been about program expansion. Discussion continued on whether the state will continue the program past DY11. (Time: 2:11 p.m.)

#### 6. <u>AI-33858</u> RTC monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the February 8, 2018 RTC (Regional Transportation Council) meeting. The big discussion was on what the RTC's response would be to the Texas Transportation Commission's decision not to move forward with IH 635/LBJ East. Michael Morris, Director of Transportation, NCTCOG (North Central Texas Council of Governments) presented the RTC with three projects to defund in order

to come up with \$1.5 billion. Collin County was not one of the three projects presented; however, the three were Dallas County projects that have major repercussions to Denton, Rockwall and Grayson Counties. The projects were the major thoroughfare/limited access roadway improvements for those counties. The action was tabled until the March meeting.

The Commissioner continues to advocate that Collin County is the fastest growing county in the country; therefore, money shouldn't be taken away from the County which would leave no way to fund infrastructure for ten years. So far this has worked, but it could change come the March meeting. He believes the RTC will make a decision at that time.

There was a work session on Mobility 2045. Nothing has changed, but it is rapidly moving forward. The Commissioner hopes to have a map of Collin County to show the Court by the next report. (Time: 2:17 p.m.)

Judge Self updated the Court on the last NCTCOG (North Central Texas Council of Governments) Executive Board meeting. NCTCOG sent a letter to Energy Secretary Rick Perry suggesting the Clean Cities Coalition needs work because it is predicated on the region needing energy when the region is the third largest energy producer.

There was a discussion on using CMAQ (Congestion Mitigation and Air Quality Improvement Program) money on a bicycle trail, which Judge Self questioned, but the item passed.

The Regional SWAT (Special Weapons and Tactics) Working Group asked to put PVS 14 Night Vision Goggles on the list to buy. The Judge suggested including thermal vision goggles on the list.

TDCs (Transportation Development Credit) qualify as the local match for federal dollars; therefore, the Judge said the County needs to be looking at projects to spend TDCs.

Judge Self asked for the accounting of the RTR (Regional Toll Revenues) dollars. This will be put on the NCTCOG agenda once the Director of Transportation completes it.

Casa (Collaborative Adaptive Sensing of the Atmosphere) Radar was also discussed. A resolution was passed to allow cities to participate with Casa Radar if they choose to do so. (Time: 2:21 p.m.)
