GENERAL DISCUSSION

5. Al-45072 Elected Official Compensation Presentation, Human Resources.

Cynthia Jacobson, Human Resources, came forward with a PowerPoint presentation on Elected Official Compensation. The presentation included salary history by percentage, base salary and supplements for the last five years. HR uses multiple ways to compare data for Elected Official compensation in Collin County. The first is a salary ranking comparison with surrounding counties: Dallas, Denton, and Tarrant. The next is a salary ranking comparison, but with "like"/high growth counties: Denton, Fort Bend, Montgomery, Tarrant, and Williamson. HR also uses the ranking comparison for the top ten counties by population: Bexar, Dallas, Denton, Fort Bend, El Paso, Harris, Hidalgo, Tarrant, and Travis. The data from all the counties in the ranking comparison is used to create a five-year salary average by percentage, a five-year total by percentage as well as the percent change for each of the last five years. Lastly, HR compares the ranking actuals of the current year with the surrounding counties, "like" counties and the top ten counties by population. (Time: 1:42 p.m.)

6. Al-33858 RTC monthly update, Commissioner, Precinct 2.

Commissioner Williams updated the Court on the July 12, 2018 RTC (Regional Transportation Council) meeting. The RTC approved the request made by the Director of the NCTCOG (North Central Texas Council of Governments) for permission to have a discussion with the FHWA (Federal Highway Administration) regarding the US75 technology lanes/HOV (High-Occupancy Vehicle) lanes. There continues to be difficulty getting agreement from FHWA to allow the RTC to take down the pylons on US75 in order to create a technology lane. The FHWA says HOV users have to be treated differently than single-occupancy users in some way. With the approval, the Director will be able to discuss options with FHWA before pursuing any one option further. One possible option is a reward system for HOV lane users.

The RTC is dealing with accounting issues with TxDOT (Texas Department of Transportation) which could result in more cash flow to the region. This is due to the way TxDOT accounts for a year versus the RTC's rolling year. There is funding being caught in the middle.

The RTC is looking at flexibility for staff to accept recommendations to move dollars around from the Surface Transportation block grant. A significant number of those federal dollars have not been used by other states and the federal government wants the funds used; therefore, other states/local governments can use the funds on qualifying projects. The RTC staff has identified \$40 million Category 2 and Category 12 funds which could be replaced with the grant funds to free up local dollars. They will continue to look through projects to see if more local dollars can be replaced.

Lastly, the Bylaws Revision Subcommittee presented the first reading of revised Bylaws. (Time: 1:45 p.m.)
