## **GENERAL DISCUSSION**

5. **AI-38983** North Central Texas Council of Governments (NCTCOG) Executive Board monthly update, County Judge.

Judge Self updated the Court on the last NCTCOG (North Central Texas Council of Governments) Executive Board meeting. NCTCOG received \$1.9 million from the Homeland Security Grant, and nearly 30% of that is spent on salaries. The NCTCOG staff is quite a bit larger than the staffs in the other COGs, and Judge Self believes too much money is being spent on bureaucracy and not enough going into the field.

The next item was the RTC (Regional Transportation Council) loaned the City of Addison \$5 million for the Cotton Belt Rail Line. Commissioner Webb said the RTC had budgeted paying the \$5 million but not during this time period. When Addison sells their bonds, they will repay the \$5 million with interest.

The Executive Board voted to spend local RTC (Regional Transportation Council) funds on a bicycle park and rain gardens. If Judge Self had been able to attend the meeting, he would have objected to transportation funds being spent on renovating parks.

The last item of interest was the Clean Cities Act which is based on energy independence. Since Texas is producing more oil than it uses and is exporting oil, the Judge questioned why we are still in this program. A letter was sent to Secretary Perry, U.S. Department of Energy, regarding this issue. The Department of Energy responded stating they want to improve energy efficiency, energy security, and reduce the cost to consumers and businesses. The COG considered it a success to have a federal program change its priorities. (Time: 1:35 p.m.)




**EXECUTIVE SESSION**

The Court did not recess into Executive Session. There being no further business of the Court, Judge Self adjourned the meeting at 1:36 p.m.




