

**ASSIGNMENT AND ASSUMPTION OF INTERLOCAL COOPERATION  
AGREEMENT FOR LAW-ENFORCEMENT SERVICES**

This Assignment and Assumption of Interlocal Cooperation Agreement for Law-Enforcement Services (this "Assignment") is entered into by Boat Investments, LP, a Texas limited partnership ("Assignor") in favor of Collin County Municipal Utility District No. 2 ("Assignee").

**WITNESSETH**

WHEREAS, Assignor is a party to that certain Interlocal Cooperation Agreement for Law-Enforcement Services, dated August 28, 2018, between Assignor and the Collin County, Texas, (the "Agreement"), attached hereto as Exhibit "A"; and

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the Agreement and Assignee desires to accept such assignment and assume all of Assignor's duties and obligations under the Agreement.

NOW, THEREFORE, in consideration of the sum of Ten and No/100 Dollars (\$10.00) paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged and confessed, it is agreed as follows:

1. Assignment and Assumption. Assignor, pursuant to Section 14 of the Agreement, hereby assigns to Assignee all of Assignor's right, title and interest in and to the Agreement. Assignee hereby assumes the obligations of Assignor under the Agreement.
2. Counterparts. This Assignment may be executed in counterparts, all such executed counterparts shall constitute the same agreement, and the signature of any party to any counterpart shall be deemed a signature to, and may be appended to, any other counterpart.


