Hi Angela and Jill,

I'm sorry to report that effective July 1st we are implementing a 6% price increase on most of our manufactured products and some direct sales items. Please find price list attached. It is with great reservation that we implement these price increases during the year rather than at year end. However, we've experienced extreme margin pressure as a result of multiple price increases from our steel, aluminum, and plastic suppliers. As you probably know, we purchase our raw materials from domestic sources, however, our suppliers are getting squeezed from buyers who were affected by the recent tariffs and are scrambling to find new sources for their raw materials.

It is our hope that delaying the increases until July 1st will give you the necessary time to update your websites and internal systems. Again, we understand the hardship mid-year price increases cause, and it's with great concern that we do this. But margin pressure has been so extreme this year and we simply can't put it off any longer.
