WHEREAS, the Splendor Cultural Education Facilities Finance Corporation ("Corporation") created by the City of Splendor, Texas has adopted a resolution authorizing the proposed loans (the "Loans") in the maximum principal amount of \$9,500,000 under a loan agreement among the Corporation, First United Bank and Trust Company (the "Bank") and My Possibilities (the "Borrower") as provided pursuant to Chapter 337, Texas Local Government Code (the "Act") for the purpose of financing and refinancing the cost of acquisition, construction, furnishing, and equipping of an approximate 40,000 square foot building located at 3601 Mapleshade Lane, Plano, Texas 75075 used by the Borrower for administration, operations and adult education (the "Project");

WHEREAS, section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") requires that the issuance of any qualified 501(c)(3) obligations be approved by either the governing body of the County or the chief elected executive officer of the County after a public hearing following reasonable public notice;

WHEREAS, attached hereto as Exhibit A is a Notice of Public Hearing (the "Public Notice") which was published in a newspaper of general circulation in the County as required by section 147(f) of the Code which public hearing was conducted by the Corporation;

WHEREAS, the comments received from the public at the Public Hearing referenced in the Notice are summarized in the Certificate of Public Hearing attached as Exhibit B hereto;

WHEREAS, attached hereto as Exhibit C is the approval of the highest elected official of the County; and

**THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF
COLLIN COUNTY, TEXAS THAT:**

Section 1. The County hereby specifically approves the Loans and the Project solely for the purpose of satisfying the requirements of section 147(f) of the Code and for no other purpose and is not to be construed as an undertaking by the County. The Loans shall not constitute a liability, an indebtedness or obligation of the County nor shall any of the assets of the County be pledged to the payment of the Loans.

Section 2. The County Judge is authorized to execute and deliver the Resolution.

Section 3. This Resolution shall become effective immediately upon its passage.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Splendora Cultural Education Facilities Finance Corporation (the "Corporation"), a nonprofit corporation created by the City of Splendora, Texas pursuant to Chapter 337, Texas Local Government Code, as amended, as amended, will hold a public hearing on September 4, 2018, commencing at 10:00 a.m., at My Possibilities, 3601 Mapleshade Lane, Plano, Texas 75075, to provide an opportunity for all interested persons to be heard with respect to a proposed loan from First United Bank and Trust Company (the "Lender") to the Corporation in the maximum amount of \$9,500,000, and a proposed loan from the Corporation to My Possibilities (the "Borrower") in the same amount (collectively, the "Loans"); all pursuant to a Loan Agreement by and among the Corporation, the Lender and the Borrower.

The Loans are being made for the purpose of financing and refinancing the cost of acquisition, construction, furnishing, and equipping of an approximate 40,000 square foot building located at 3601 Mapleshade Lane, Plano, Texas 75075 used by the Borrower for administration, operations and adult education (the "Project"). A portion of the proceeds of the Loans may be used to pay certain expenses in connection with the issuance of the Loans. The Project is, or will be, owned or operated by the Borrower. The Loans are not payable out of taxes and are secured by and payable solely from funds provided by the Borrower.

All interested persons are invited to attend the hearing to express their views, both orally and in writing, with respect to the Loans and the Project. Any interested persons unable to attend the hearing may submit their views in writing to the President of the Board of Directors of the Corporation c/o Orrick, Herrington & Sutcliffe LLP, Attn: Hoang Vu, 609 Main Street, 40th Floor, Houston, Texas 77002, prior to the date scheduled for the hearing.

APPROVAL OF HIGHEST ELECTED OFFICIAL OF COLLIN COUNTY, TEXAS

WHEREAS, My Possibilities (the "*Borrower*"), in connection with a tax-exempt financing in the aggregate principal amount of \$9,500,000, has requested the approval of the Financing (as described below) and the Project (as defined below) located in Collin County, Texas; and

WHEREAS, the "*Financing*" consists of a loan agreement among the Borrower, Splendor Cultural Education Facilities Finance Corporation (the "*Corporation*") and First United Bank and Trust Company (the "*Lender*") through which the Lender will make a loan to the Corporation, which in turn will make a loan to the Borrower for the purpose of (A) financing and refinancing the cost of acquisition, construction, furnishing, and equipping of an approximate 40,000 square foot building located at 3601 Mapleshade Lane, Plano, Texas 75075 used by the Borrower for administration, operations and adult education; and (B) paying certain expenses in connection with the issuance of the Loans (the "*Project*");


