Microsoft Windows Server Operating System Patch Update Compliance

Collin County is committed to an active patch management plan, as part of our security efforts, to ensure installation of the latest Microsoft operating system patches. Laserfiche will use commercially reasonable efforts to maintain and test their solution(s) with the latest Microsoft operating system patches, as applicable. Should Collin County find, or suspect, an incompatibility between Laserfiche solution(s) and a Microsoft operating system patch, the County will notify MCCi. Upon notification, MCCi will work with Laserfiche to provide a patch as quickly as possible. If the deployment of a full patch update is not released quickly enough to resolve an issue for Collin County, Laserfiche can make point hotfixes available through their technical support team.
