a. <u>Al-45000</u> Recognition of Congressman Johnson for his years of service to the community and nation, Commissioners Court.

Eric Nishimoto, PIO, presented a resolution declaring October 15, 2018, as Sam Johnson Day in Collin County.

Each member of the Court took a moment to speak about the Congressman.

Judge Self said Congressman Johnson is a native of North Texas who entered the United State Air Force from Southern Methodist University. While serving his country, he spent six years in Hanoi, North Vietnam. Congressman Johnson brought home with him wounds which are very specific to him, but those wounds are very representative in the work he has done throughout his career for other Veterans who have brought home their own wounds, both seen and unseen. Following his military service, he became an entrepreneur in Collin County and then fulfilled a promise he made to himself by entering into politics to make a difference. Judge Self said every member of the Court represents some part of the Congressman's constituency and have all looked to him for leadership over the decades.

Commissioner Fletcher thanked Congressman Johnson for his service to Collin County, Texas and the United States. He encouraged her personally as she made changes and ran for office. He has been a great friend and leader.

Commissioner Williams said she hopes the Congressman knows how truly wonderful he is. He is an exceptional example of how an elected official should serve their constituents. The Commissioner thanked him for his service and for being a mentor to her.

Commissioner Thomas said he was at West Point at the end of the Vietnam War and his professors, many of whom were Veterans of the Vietnam War, spoke very highly of Congressman Johnson's courage and strength of character. It was very important to have such a man to look up to in a time when the military was facing attacks and criticism. The Commissioner thanked the Congressman for his excellent example of service and leadership.

Judge Self presented Congressman Johnson with an engraved silver plate honoring his 68 years of service. (Time: 1:39 p.m.)

The bids for both will be evaluated and if a bid for a six-lane bridge works monetarily for Celina, that option will move forward. If it doesn't, a four-lane bridge will be built. The proposal for the six-lane bridge option has a provision for which Collin County will design the plans and prepare the bid documents for a full bridge. This is the same for a four-lane bridge. Collin County's funding will not change if a six-lane bridge is chosen. A motion was made to approve the item. (Time: 1:47 p.m.)
