Distribution Analysis of FY2018 Cases Paid in Collin County

Article 26.04(b)(6) of the Code of Criminal Procedure requires that local procedures for appointing counsel ensure appointments are allocated among qualified attorneys in a fair, neutral, and nondiscriminatory manner. TIDC presumes a jurisdiction has a fair, neutral, and nondiscriminatory appointment system if (for assigned counsel and managed assigned counsel systems) the top 10% of attorneys receiving cases at a given level (felony, misdemeanor, and juvenile) receive no more than 3.0 times their respective share of appointments.¹ If a county can track appointment by appointment list, this analysis is made on each appointment list. A county can overcome the presumption by providing evidence as to why the system is fair, neutral, and nondiscriminatory.

Counties report to TIDC, on an annual basis, the amount paid to each attorney and the number of cases for which those attorneys were paid. TIDC can make an analysis of appointment distributions using this data. However, this analysis is slightly different than the analysis conducted for a monitoring review in two important ways:

- 1) A monitoring review's analysis will only consider attorneys who were on the appointment wheels for the entire year.
- 2) A monitoring review's analysis will separate appointment lists to the extent possible. For instance, if separate lists are used for Spanish speakers, the monitor will make an analysis of appointments for Spanish-speaking attorneys and a separate analysis for other attorneys.

Based on cases paid (reported by the Collin County Auditor's Office to TIDC), the top 10% of attorneys receiving felony cases received 2.9 times their representative share of cases (just within the 3.0 threshold for presuming a jurisdiction's appointment system is fair, neutral, and nondiscriminatory). The distribution for misdemeanor cases was a little more even, with the top 10% receiving 2.6 times their representative share of cases. The distribution of juvenile cases was outside of TIDC's threshold (the top 10% received 3.3 times their representative share of cases). As just noted, these distributions may differ from an analysis made in the course of a monitoring review.

¹ "The top 10% of recipient attorneys is the whole attorney portion of the appointment list that is closest to 10% of the total list." 1 Tex. Admin Code § 174.28(c)(5). The target "respective share" of cases for the Top 10% of attorneys therefore may be more or less than 10%, and three times that share may be more or less than 30%.

Caseloads of Appointed Counsel

Criminal defense attorneys need to spend enough time on each case to fulfill their basic duties to defendants. TIDC, in partnership with the Public Policy Research Insitute at Texas A&M University, conducted a study to determine the maximum number of cases an attoney could carry in a year while providing ethical representation.² The study found that, in Texas, an attorney should carry no more than 226 misdemeanors or 128 felonies. The Public Policy Research Insitute made further studies which examined appeals (maximum of 31.2 appeals) and juvenile cases.³ The juvenile study was limited in that juvenile attorneys are not required to continue with the case through disposition. Many times, attorneys only represent juveniles at the detention hearing. This analysis assumes the maximum number of juvenile cases an attorney may handle to be 210 cases (the study's assessment for CINS cases – the lowest level to be filed in juvenile courts). This analysis refers to the combined maximum annual casesloads as the Guidelines.

In FY2018, 160 attorneys received payment for cases disposed by appointment in Collin County. The median attorney received \$28,600 from Collin County. If one includes appointments in other counties, the median amount received by attorneys from appointments was \$34,000, and the median caseload was 34% of the Guidelines. This sounds quite manageable, but eleven attorneys had appointed caseloads above the Guidelines. If one takes into account other parts of an attorney's practice (based on attorney practice time reports), 35 attorneys had caseloads above the Guidelines. To summarize, the majority of attorneys taking appointments in Collin County appear to have reasonable caseloads, but a significant minority of attorneys appear to have excessive caseloads.
