Judge Hill called to order the meeting of the Collin County Commissioners Court at 1:30 p.m. and recessed the meeting at 2:19 p.m. The meeting was reconvened at 2:20 p.m. and recessed into Executive Session at 2:27 p.m. The meeting reconvened at 4:21 p.m. and adjourned at 5:32 p.m.

General Discussion

5. AI-46784 2019 TCDRS, Human Resources.

Cynthia Jacobson, Human Resources, presented a TCDRS (Texas County and District Retirement System) PowerPoint presentation. The deposit rate is at 7% with a matching rate of two to one, and the vesting period is eight years. In comparison to surrounding counties, half are at 200%, and the other half are at 225% or 250%. There are more flat-rate COLAs (Cost of Living Adjustment) this year. The cities have a 5% rate of return and do repeating COLAs. The match is the same as the County, and the only difference is the cities have a slightly lower interest rate.

The ten-year rate of return shows that it is above 8%, but the five-year rate of return is below the ending balance needed. The current rate is at 6.95%, but will change in FY2020 to 7.84%. Collin County has the lowest required rate compared to surrounding counties and cities.

The cost per employee per year for retirement benefits over a ten-year period averages \$8,000. The unfunded liability uses the five-year asset recognition method, and the plan is at \$13 million plus which is a funded ratio of 97.6%. With the immediate recognition method, the unfunded liability is over \$60 million, and 93% of the unfunded liability is based on the losses of the plan that were below what was needed for it to be funded. Ms. Jacobson briefly reviewed GASB (Governmental Accounting Standards Board) statements 68 and 75, and COLAs. (Time 1:49 p.m.)

6. AI-46801 Medical Examiner Update, Medical Examiner.

Dr. William Rohr, Medical Examiner, presented a PowerPoint presentation updating the Court on the ME's (Medical Examiner) Office. There is an onsite inspection done every five years in order to

maintain accreditation by National Association of Medical Examiners. Every year an update must be submitted which includes budget information and policies and procedures. Dr. Rohr said there is an expansion plan for the work area in place that will allow them to work during construction. With the help of the County Health Unit, they were able to purchase a portable trailer where they are able to store deceased individuals if necessary.

There are people within the office that are working long hours, and therefore two new field agents are needed. Dr. Rohr had two graphs that show the total number of bodies examined and total absentia cases from FY2014-FY2018. The numbers in absentia cases have gone up resulting in more work for the office.

Dr. Rohr presented a slide showing a full body x-ray machine that is the latest in technology and is used by many Medical Examiner's Offices across the State. Although it is not being requested now, this machine would be something to consider for the future. The new cremation permit process has helped the office and its workflow. This was a multi-departmental project where the entire cremation permit process including payments is now done online.

Commissioner Webb asked what is the involvement of the investigators in the absentia cases and are the cremation permits included in the absentia cases. Dr. Rohr responded that not all cremations are included in the absentia cases but there are some. The investigators are involved in all the absentia cases due to the gathering of all the necessary information. The number of total cases has increased putting the office behind and is justification for two new field investigators. (Time 2:14 p.m.)

7. AI-46809 Assignment of a Better Living for Texans (BLT) Project Coordinator, Administrative Services.

Bill Bilyeu, County Administrator, said the employee assignment for BLT (Better Living for Texans) would assist low-income individuals with healthier living, better food options, and exercise. The Court is being asked to host the staff member which means the County will provide the facilities and acknowledge that the position is there. This is a grant-funded program and no cost to Collin County.

Annie Tinsley, AgriLife Extension Services, said Tarrant, Dallas, and Denton Counties also host this position. The funding of the salary, equipment, and food demonstrations would come from Health and Human Services.

Judge Hill asked Caren Skipworth, CIO, if the usage of the Counties network by this employment is permissible. Ms. Skipworth said the County currently works with the State and that it would not be an issue. With no further comments, a motion was made to approve the item. (Time 2:19 p.m.)

Judge Hill reconvened Commissioners Court at 4:21 p.m. and began discussions on items eight and nine on General Discussion. Michalyn Rains, Purchasing, came forward to discuss the Contract Renewal for Food Supplies. Ms. Rains explained that she needs a Buyer II level position for this. The administrative process was taking up to 75% of the former employee's time, so Ms. Raines ended the opportunity spot buys in April FY2018. Commissioner Williams expressed her frustration that this was done unilaterally and not brought to the Court because it has cost the County a significant amount of money. Ms. Raines said she was not aware of the amount of time spent on the quarterly process until the workload started affecting the work of another employee. Commissioner Williams said the County has to have the opportunity to reduce food costs and told Ms. Rains to do whatever is necessary to make sure the County is able to make the necessary buys in order to reduce the costs. Commissioner Williams wants to see this come back at budgeting with an explanation of what job duties are suffering and the priorities.

Judge Hill asked Monika Arris, Budget, what the expenses on food were for FY2018. Ms. Arris stated the jail operations food supplies was budgeted at \$1.2 million for FY2018 and the actuals came in at \$1.3 million. The food supply in minimum security was budgeted at \$140,000 and \$116,000 was spent. The jail café had a budget of \$42,000 and \$39,900 was spent. The budget for jail operations for food supply in FY2019 is \$1.3 million and it is currently at \$1.25 million. The budget for minimum security

is \$100,000 and is currently at \$119,000, and the budget for the jail café is \$22,000 and is currently at

\$22,200.

Commissioner Hale asked if there have been changes to the food standards as far as caloric intake.

Sheriff Jim Skinner came forward and said the dietician did make an increase in caloric intake earlier

this year. There are 23,100 meals served each week totaling over \$4,000 per day. The Sheriff agreed

with Ms. Rains on the staggering amount of work required in dealing with spot contracts. An extensive discussion ensued regarding the budget for food supply, food costs and the number of meals served.

Sheriff Skinner said implementing the opportunity buy system and working with Purchasing will help

reduce the cost significantly. Judge Hill asked if the shortfall could have been avoided by having the

opportunity spot buy system. The Sheriff said it is a combination of all these factors including the

increase in population and inmates.

Judge Hill would like to figure out what the real factor is behind the increase in cost and if it is related

to staffing, inmate population increase or the rise in food prices. Commissioner Williams suggested exercising the process of opportunity buys between now and the end of the year with the existing staff

to quantify the costs. With no further comments, a motion was made to approve items 8 and 9.

Judge Michael Missildine, Justice of the Peace, Precinct 3-2, came forward and said he disagreed with abolishing one court or combining the two. With the increase in population, this would only cause more problems including added docket time and staffing issues. Dockets are already full and by combining these courts the docket time will only increase. Mr. Missildine says that we have to think about access to justice. Judge Missildine said he is willing to do whatever needs to be done.

Judge Hill said Precinct 3-1 Court was overwhelmed with cases and 3-2 was under performing because people had the opportunity to choose a court. If Judge Missildine no longer handled magistration and handled truancy differently, this would provide him with several hours of additional time. With four independent precincts on equal footing, there is a statute that allows the County Judge to appoint a temporary Judge as needed to help with the docket. Judge Missildine has been working on handling cases more efficiently than how they have been handled.

Judge Hill called Judge Chuck Ruckel, Justice of the Peace, Precinct 3-1 forward. Judge Ruckel hopes the Court will reach out to the people that are being affected and alleviate their stress and concerns. With the increase in jurisdictional limits, the increase in population, and the numbers we already have in the courts, we need more people not fewer. Sammy Knapp, Constable, Precinct 3, said he guarantees to be there to serve papers. Even with the increase in caseloads, they will be team players and make it work. With no further comments, a motion was made to approve the order of Commissioners Court abolishing the office of Justice of the Peace, Precinct 3-1, as of December 31, 2020. (Time 5:32 p.m.)
