DESCRIPTIONS and SPECIFICATIONS of RIGHTS GRANTED

RIGHTS GRANTED	
By TxDOT	By Grantee
<ol style="list-style-type: none"> 1. TxDOT will provide Grantee rights to obtain all its Traffic Data including traffic camera full-motion images, and to access, select and distribute them publically on Grantee websites and social media platforms. 2. TxDOT will provide Grantee the right to use TxDOT Lonestar software as a user client at a secure level to be determined by TxDOT to obtain the Traffic Data. 3. TxDOT will provide documentation to Grantee to configure the TxDOT Lonestar software Closed Circuit Television (CCTV) client with privileges of camera selection and access to pan, tilt, and zoom at a secure level to be determined by TxDOT. Guidelines for use of TxDOT CCTV are detailed in Attachment B. 	<ol style="list-style-type: none"> 1. Grantee shall provide TxDOT rights to obtain all its Traffic Data including traffic camera full-motion images, and to access, select and distribute them publically on TxDOT websites and social media platforms. 2. Grantee shall provide TxDOT the right to use Grantee software as a user client at a secure level to be determined by Grantee to obtain the Traffic Data. 3. Grantee shall provide TxDOT the right to obtain its Geo coded 911 incident alert data with incident descriptors for topical map plotting and incident location ID, emergency vehicle and law enforcement response status and location ID, and situational awareness content. 4. Grantee shall provide documentation to TxDOT to configure the Grantee software client with privileges of camera selection and access to pan, tilt, and zoom at a secure level to be determined by Grantee. Guidelines for use of Grantee CCTV are detailed in Attachment B.

<ol style="list-style-type: none"> 1. TxDOT will provide a connection into its TMC and space for Grantee equipment required for Grantee to obtain TxDOT traffic camera full-motion images. The connection demarcation is noted on the attached communications diagram. 2. TxDOT will provide a connection into its Statewide portal for Grantee to obtain Traffic Data. 3. TxDOT will enable Grantee's Lonestar software client to access the required TxDOT TMC software via the internet. 4. TxDOT will provide and maintain all communication links, hardware, software, and additional ITS infrastructure that is necessary to obtain Grantee's traffic data and full-motion video. 5. TxDOT will provide Grantee with (a) verifiable, static, routable IP address(es). 	<ol style="list-style-type: none"> 1. Grantee shall provide a connection into its TMC and space for TxDOT equipment required for TxDOT to obtain Grantee traffic camera full-motion images. The connection demarcation is noted on the attached communications diagram. 2. Grantee shall provide a connection into its portal for TxDOT to obtain Grantee Traffic Data. 3. Grantee shall provide a connection for TxDOT to obtain Grantee Geo coded 911 incident alert data. 4. Grantee shall enable TxDOT to access the required Grantee software via the internet. 5. As described in Article 3-Provision of Infrastructure, Grantee is responsible for providing and maintaining all communication links, hardware, software, and additional ITS infrastructure that is necessary to obtain the Traffic Data and video full-motion video. 6. Grantee shall provide TxDOT with (a) verifiable, static, routable IP address(es).

Grantee may transmit video data to TxDOT with an embedded logo; TxDOT will not block, modify, or remove the Grantee logo. 	<ol style="list-style-type: none"> 1. Grantee shall give TxDOT and/or TMC voice and/or visual credit (TxDOT and/or TMC logos) for all TxDOT Traffic Data and video. <ol style="list-style-type: none"> a. TxDOT may transmit video data to Grantee with an embedded logo; Grantee shall not block, modify, or remove the Logo. b. TxDOT will provide Grantee with TxDOT logos for identification of its traffic data and video images. The use of the TxDOT and/or TMC logos is limited to giving TxDOT credit for contributed data. Grantee shall not use the logos for any other purpose. 2. Grantee shall waive any monetary fee associated with the use of its ITS data and video.
