Hearing no comments, the public hearing was closed at 1:40 p.m. With no further comments, a

6. AI-46786 2019 Benefits, Human Resources.

Cynthia Jacobson, Human Resources, presented a PowerPoint presentation with a review of Collin County's 2019 benefits. Benefits are one of the larger costs for the county. The FY2018 costs did rise, but there was also an increase of over fifty people per month associated with the rise in costs. The County pays

the majority of the medical expense with employees paying just over ten percent of the expense. Over the past five years, the real-dollar cost for employee's coverage has not changed. The budget is less than what the claims costs are expected to be. The average employer premium cost per employee for FY2018 was \$16,982. Collin County is at the higher end of the premium cost paid when compared to other entities. These entities include: the cities of Dallas, Plano, Richardson, Frisco, McKinney, and Allen; Williamson, Fort Bend, Grayson, Dallas, Montgomery, Travis, Tarrant, Denton and Rockwall counties; the State of Texas; the NTTA (North Texas Tollway Authority); the NTMWD (North Texas Municipal Water District); and Mercer.

Catastrophic cases are 50% of the claims costs and have increased 7% from last year. The top diagnosis categories are cancer, musculoskeletal, injury and poisoning, and circulatory system. Cancer claimants increased by 13%, and the cost of claims increased by 81%. This year the cancers were mostly with children, and the County is required to cover children up to age 26. Musculoskeletal claimants increased by 2%, and 52% of claim dollars were for high-cost claims. Injury and poisoning claimants increased by 5%, and the cost of claims increased 57%. Circulatory system claims decreased by 0.3%, and 48% of the claim dollars were for high-cost claims.

The stop loss fee is the first \$100,000 of a claim, and the insurance carrier covers the amount over the \$100,000. There has been a dramatic increase over the years, and it will continue to rise due to the increase in high-cost claims. The ER (Emergency Room) visits net pay increased 1.4% and is 29% higher than the norm. The pharmacy costs are 19% of total costs and have decreased 10%. There are fifteen top drugs that cost Collin County \$2 million and comprise 41% of the County's pharmacy cost. Ms. Jacobson briefly reviewed the top fifteen prescriptions and prices of specialty drugs.

Medical plan deductibles are low when compared to the other entities. The out-of-pocket expense increased to \$3,000 and is equivalent to most of the other entities. The physician co-pay is low to encourage employees to visit the physician rather than seeing a specialist because there is a significant difference in cost between the two.

The dental plan deductible is \$50 and consistent with other entities. The maximum is \$1,000 which is lower than the majority of our counterparts. Only 11% of the employees used the maximum level of benefits. The employee-only coverage cost is \$119 and on the higher end when compared to the other entities. Employee and spouse coverage cost is \$250, employee and children is \$205, and employee and family is \$330 placing Collin County on the lower quartile compared to other counties. Ms. Jacobson briefly reviewed the costs of different medical and dental plans available for the employees.

There have been no major changes in terms of benefits. An on-site nurse liaison focused on back health, diabetes, cancer support and education, and catastrophic/in-patient claimants. One out of ten enrolled members are diabetic and this includes children. There are 326 members with diabetes and 289 of them

have risk factors. Diabetes with complication claims paid per member per month has decreased 5% and the County is 42% lower than the peers.

According to United Healthcare, Collin County had the highest wellness utilization on their book of business. Over 50% of Collin County employees are considered obese, and a multitude of programs have been tried but have not been successful. Ms. Jacobson concluded her presentation saying changes will not be recommended until an insurance carrier is determined and plan is chosen. (Time 2:12 p.m.)

# 7. AI-46788 2019 Law Enforcement Compensation, Human Resources.

Cynthia Jacobson, Human Resources, presented a PowerPoint presentation on Law Enforcement Compensation. The pay ranges, turnover, and supplemental pay were compared to the following organizations: Bexar, Dallas, Denton, El Paso, Fort Bend, Montgomery, Tarrant, Travis, and Williamson Counties; the Cities of Allen, Carrollton, Dallas, Frisco, Garland, McKinney, Murphy, Plano, Richardson and Wylie; and the Town of Prosper. Changes to the requirements for several positions were made in FY2018 resulting in changes to the number of position matches. The turnover for Law Enforcement positions is 19.4% and these are mainly jail positions. The top three reasons for leaving are: 1) returning to school; 2) other job offers; and 3) retirement. The SO (Sheriff's Office) is consistent with Denton County when comparing turnover percentages. Fort Bend has the lowest percentage, but it was determined that pay rate was not a factor.

One third of Detention Officers are in the top 50% quartile and are long-term employees. Deputy Constables have 72% that are in the top 50%, and Deputy Sheriffs have 48% in the top 50%. Commissioner Fletcher asked if any of the counties we are compared to pay the Deputy Constables and Deputy Sheriffs on a different salary grade since they are both licensed peace officers. Ms. Jacobson said she would find that information. Exit interviews are conducted upon termination, and 48% of law enforcement employees who terminated in FY2018 responded. Over 75% agreed or strongly agreed that compensation was adequate for their position.

Supplemental pay compared to the other counties is similar except for the special teams. The cities do not pay as much for special teams or shift differentials. Collin County has a higher shift differential pay when compared to the other counties and cities. Salary adjustments are done each January to avoid compression issues and to keep employee wages competitive with the job market.

There are 281 Detention Officer positions with an average of six years of service. Detention Officer positions rank 5% over the city/county average minimum pay and 3% over the average maximum pay. There are 23 Dispatcher positions with an average of six years of service. Dispatcher positions rank 9% over the city/county average minimum pay and 1% over the average maximum pay. There are 81 Deputy Sheriff

positions with an average of nine years of service. The pay rank for Deputy Sheriff positions is 3% above the city/county minimum average pay and 2% above the maximum average pay. There are 4 Criminal Investigator positions with an average of 16 years of service. The pay rank for Criminal Investigator is 4% above the city/county minimum average pay and 3% above the maximum average pay. There are 8 Sergeant positions with an average length of service of 14 years, and the pay rank is 4% below the city/county average maximum pay.

There are 20 Lieutenant positions, and their average length of service is 14 years. Collin County does not differentiate Lieutenant pay based on area of assignment, and all are paid under the same pay scale. Lieutenant pay rank is 2% above the city/county maximum pay. There are 8 Captain positions with an average of 19 years of service and are ranked 4% below the city/county average. Travis County has a significantly higher maximum pay rate compared to the other cities and counties. Removing Travis County from the rankings, Collin County's pay rank is third out of five and 2% over city/county average maximum pay. The Deputy Constable has 20 positions with an average of 10 years of service. The pay rank is 12% above average minimum pay and 8% above average for maximum pay. There are 20 Court Officer positions with an average length of service of 18 years. The Court Officer pay rank is 1% below the city/county average for minimum pay and 5% below the average maximum pay. There are two Deputy Fire Marshal positions with an average length of service of 3 years. The pay rank is 10% above city/county average minimum pay and 5% above the average maximum pay. (Time 2:32 p.m.)

# 8. AI-44358 Conference of Urban Counties Update, Commissioner, Precinct 3.

Commissioner Hale filled in for Commissioner Fletcher and attended the policy meeting and lunch education session. The primary focus was the legislative update, bills that would affect the County, and concerns about unfunded mandates. HB914 requires bingo operators to pay a portion of their proceeds to the County. If the County does not take action by November 1, 2019, the County will forgo any bingo proceeds available to the County through the fee established by this bill. The proceeds would then go to the State Lotto Commission and they would in turn give half of the amount to various non-profit organizations.

Commissioner Hale said HB305 states that the filing deadlines for all county elected officials have to be posted on the website the year before. HB1495 requires the County to include in the budget expenditures that directly or indirectly influence legislation. There are several opinions among TAC (Texas Association of Counties), CUC (Conference of Urban Counties) and county attorneys as to what indirect influence actually means.

HB2840 codifies public comments so that a session must be held in totality prior to each meeting or prior to each item on the agenda. It also states that each individual must have the same amount of time to speak.

This relates to any open meeting which could include budget workshop. There was a brief discussion on how the time would be allotted.

HB3834 requires every individual with access to a county computer system to complete Cybersecurity training and be certified. SB944 states there must be copies of any public information kept on personal devices. The best way is to route all County business through the County email in order to archive County records. SB601 requires counties to make mental screenings available in the form of an interview as opposed to a simple screening. Screenings are already practiced as an interview format in Collin County through Alyse Ferguson, MHMC (Mental Health Managed Counsel).

Lastly, a recommendation was made for counties to examine where backup body cam footage is stored. Once any data is turned over as evidence, it shouldn't be kept at both the Sheriff's Office and the District Attorney's Office. This data is being replicated many times, and there needs to be a review of what data is kept and for how long.

During the lunch portion Mark Williams, Deputy Executive Director of TxDOT (Texas Department of Transportation), spoke about the amount of money being put into the Texas state roads. Proposition 1 funds are derived from severance taxes from oil and gas. In 2020, there will be \$1.67 billion dollars allocated to Texas highways and roads, and in 2021, another \$1.46 billion will be allocated. Proposition 7 is the State's sales tax portion. The legislature borrowed from this in 2018 bringing the amount down. There will be \$4.06 billion dollars allocated towards Texas highways and roads in 2019. In the following two years, there will be \$2.5 billion dollars each year.

There is also a 2020 Unified Transportation plan with an online draft and a public hearing scheduled August 6, 2019 at 10:00 a.m. looking for feedback. This transportation plan will allocate \$76 billion over the next ten years with \$28 billion of that specifically for congestion. (Time 2:45 p.m.)
