Below is the scope and fee for Amendment 3 to the requested updates to the Collin County Thoroughfare and Transit Plan and additional travel demand model runs. This Amendment 3 will update TASK 4 On-Call Transportation Consultation in the Scope of Services: Collin County Mobility Plan Additional Demographics and Travel Demand Modeling Services Agreement dated May 19, 2015 for an additional agreed upon fee.

#### TASK 4 ON-CALL TRANSPORTATION CONSULTATION

At the sole discretion of Collin County, the Engineer shall provide additional services, to include such services as on-call travel demand modeling, traffic analysis, transportation planning, alternatives analysis and conceptual design services. These services shall be documented via letter or e-mail correspondence, where the requested scope, fee and schedule, as negotiated by the County and the Engineer, are identified for each request. Payment terms for this work shall be in accordance with the overall contract payment terms.

#### 4.6.1 Schedule

It is anticipated that each travel demand model run will be completed within two (2) weeks, with the maximum of ten travel demand model runs being completed within twenty (20) weeks from notice to proceed on this task.

#### 4.6.2 Deliverables

Travel Demand Model results described above shall be provided for the 2035, 2.1M and 3.4M Build-Out scenarios, in TransCAD and ESRI shapefile formats.

#### 4.6.3 Task Status

Task not started. Task added as part of this addendum. The proposed fee to complete this task is \$49,178.20.

## 4.7 NCTCOG 2045 Demographics Adjustments

Collin County has requested the creation of a set of 2045 demographics that adjusts the NCTCOG demographics to move population from overpopulated zones to the next zone to the north or east. This task includes a maximum of one additional travel demand models runs with the new demographics.

## 4.7.1 Schedule

It is anticipated that the adjustments and the travel demand model run will be completed within six (6) weeks from notice to proceed on this task.

#### 4.7.2 Deliverables

Travel Demand Model results for the 2045 demographics, in TransCAD and ESRI shapefile formats.

#### 4.7.3 Task Status
