2. Public Comments.

John Stafford, Plano, said the one-time payment of \$20 made to election clerks and judges for training is in violation of the Texas Minimum Wage Act. The training is four and a half hours long, and if the clerks were paid at the minimum wage, the total would be approximately \$35. The judges have two additional hours of training and, at the minimum wage, they would be paid approximately \$50. The County could be at risk of a lawsuit by not complying with state and federal laws. Mr. Stafford said this could be fixed today and hopes it will.

Judge Hill asked if it is a requirement to pay the clerks for this training. Bill Bilyeu, County Administrator, said, according to the Election Code, payment for this training is optional. Election workers are under a separate category, and payments are set by the Election Code. The State funds primary elections and allows \$10 for training. Bruce Sherbet, Elections, said this is a one-time training to get all employees acclimated to the new voting system, and the response has been extremely positive. (Time: 1:37 p.m.)

The Judge said a janitorial contract for the Workforce Board was the main topic of discussion. Representatives for Dallas County and the City of Dallas wanted the NCTCOG Board to reject the contract until the vendor was required to guarantee they are providing the minimum wage. The intention is to have a policy with all vendors that their contracts require a minimum wage statute or guideline.

The NCTCOG service area consists of 16 counties, and what is considered a minimum living wage in the City of Dallas is different from other counties. The staff tried to determine how this would be executed in the future with all the contracts that go before NCTCOG. The contracts may need to be broken down to 16 different contracts and that could be problematic. The contract passed without amendment with a 9 to 4 vote. It was requested the item be added to a future agenda for further discussion. The Workforce Board is independent, and has chosen the NCTCOG as their financial agent. This suggests that the NCTCOG Board doesn't have the authority to say how much will be paid in the contracts. Judge Hill said he made a point that Dallas County and Tarrant County are not part of the Workforce Board. This means that neither Dallas County nor the City of Dallas would be affected by this contract because they have their own separate Workforce Board. (Time: 1:50 p.m.)


