FIRST AMENDMENT TO
INTERLOCAL COOPERATION AGREEMENT
FOR LAW-ENFORCEMENT SERVICES

THIS FIRST AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT FOR LAW-ENFORCEMENT SERVICES (this “**First Amendment**”) is made effective as of October 1, 2019, by and between **COLLIN COUNTY** (“**County**”), and the **COLLIN COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 03** (“**CCWCID**”), a Water Control and Improvement District.

RECITALS:

A. County and CCWCID entered into that certain Interlocal Cooperation Agreement for Law-Enforcement Services with an Effective Date of October 1, 2017 (the “**Agreement**”).

B. County and CCWCID have reviewed and evaluated the terms and provisions of the Agreement and desire to modify the Agreement upon and subject to the terms and conditions set forth in the First Amendment.

AGREEMENT:

NOW, THEREFORE, for and in consideration of the Recitals, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and CCWCD hereby amend the Agreement as follows:

1. Capitalized Terms. Unless otherwise defined herein, all capitalized terms used in the First Amendment shall have the same meanings as assigned to such capitalized terms in the Agreement.

2. Section 1 - Term. The term of the Agreement is hereby extended for a period of one (1) year. The Expiration Date, as defined in Section 1 of the Agreement is hereby amended to be September 30, 2020.

3. Section 2.3 of the Agreement is hereby amended by deleting the fourth sentence in its entirety and replacing it with the following: ““**Liaison Officer**” means: Commander Parrish Cundiff, Collin County Sheriff Office, 4300 Community Avenue, McKinney, Texas 75071 (972) 547-5100, pcundiff@co.collin.tx.us, or such other person identified by the County to be the Liaison Officer, by written notice to CCWCID from time to time during the term of this Agreement.”

4. Exhibit A and Exhibit C. Effective as of the date of this First Amendment, Exhibit A and Exhibit C attached to the Agreement are hereby deleted in their entirety and Exhibit A and Exhibit C attached to this First Amendment are hereby inserted in their place.

5. Miscellaneous.

(a) Except as amended hereby, the terms of the Agreement remain unchanged and in full force and effect as originally written.

(b) County and CCWCID acknowledge and agree that there are no unwritten, oral agreements between the parties and that this First Amendment may be amended, modified or changed only by a traditional written document properly executed by the parties.

(c) In the event of any conflict between the meaning of any provision of this First Amendment and any provision of the Agreement, the provisions of this First Amendment shall control.

(d) All the covenants, terms, and conditions set forth herein shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, executors, administrators, legal representatives, successors, and assigns.

(e) This First Amendment may be executed in multiple counterparts and may be transmitted by e-mail, facsimile, or other method permitted by the


provisions for giving notice in the Agreement, and in several counterparts, and each counterpart shall constitute an original instrument, and all counterparts shall constitute one and the same instrument.


