A RESOLUTION OF THE CITY OF ANNA, TEXAS APPROVING EXTENSION AND AMENDMENTS OF THE AGREEMENTS WITH COLLIN COUNTY FOR ANIMAL SHELTER SERVICES.

WHEREAS, the City Council of the City of Anna, Texas ("City Council") finds that the agreement with Collin County for providing Animal Shelter Services to the citizens of Anna is worthy of continuation; and

WHEREAS, the City Council approves Collin County's amendment to the current Animal Shelter Services agreement, to include the following fee:

"The total amount for fiscal year 2020: \$24,220.00

Section 1. Recitals Incorporated

The recitals set forth above are incorporated herein for all purposes as if set forth in full.

Section 2. Approval and Authorization of Agreement

The City Council hereby approves the extension attached hereto as Exhibit 1 to extend the agreement with Collin County for Animal Shelter Services; and approves the Amendment to the original Agreement attached hereto as Exhibit 2, ratifies and approves the City Manager's execution of the same. The City Manager is hereby authorized to execute all documents and to take all other actions necessary to finalize and enforce the animal shelter agreement with Collin County.
