The recitals set forth above are incorporated herein for all purposes as if set forth in full.

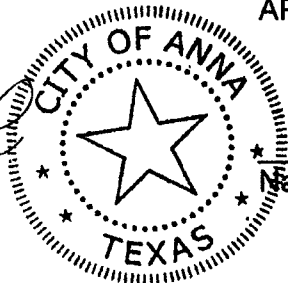
**Section 2. Approval and Authorization of Agreement**
