1. Judge Hill called to order the meeting of the Collin County Commissioners Court Special Session at 11:00 a.m.

2. Public Comments.

Commissioner Webb said today was the 6th anniversary of the Collin County Portraits of Heroes Dedication Ceremony. Today is also Veterans Day and its 100th year anniversary. The Commissioner thanked and recognized all the Veterans.

R.D. Foster, Vietnam Veteran, came forward to present six portraits of Collin County fallen warriors to be put on permanent display at the Russell A. Steindam Courts Building.

Wesley M. Adamson, 19, of Weston, U.S Army. Wesley was killed-in-action October 19, 1918, at St. Etienne, France, while his regiment was fighting under the command of the 4th French Army. Wesley is buried at Rowe Cemetery in Hedley, TX. He was awarded the French Croix de Guerre with Silver Star. Colin Kimball, an Air Force Veteran and creator of the portraits, gave a description of the portrait and a brief account of the events leading up to Wesley's death.

Noble Lee Birket, 18, of Wylie, U.S. Army, Pvt. 314th Inf. Regt. 79th Inf. Div. (Cross of Lorraine Division). Killed-

in-action March 25, 1945, when his unit crossed the Rhine River into Germany. Noble is buried at the Netherlands

American Cemetery.

Harold L. Chrismon, 25, of Celina, North Texas State College, U.S. Army Air Force Major. Flying Fortress pilot,

flew over 40 combat missions in World War II. Killed in a search-and-rescue mission when his plane collided mid-

air with another Flying Fortress in the Pacific Ocean on July 20, 1946.

Henry Carl Chrismon Jr., 22, of Celina, U.S Army Air Corps, 1st Lt. 8th Air Force, 413 Bomber Sq., 96th Bomber

Group Heavy. On November 21, 1944, he was a pilot of a B-17G with a crew of nine. His plane was hit by flak and

exploded in the air near Osnabruck, Germany, in World War II. He was brother to Major Harold Chrismon, who

we also have a portrait of. Mr. Kimball said Henry had left his pregnant wife at the time he died, and was honored

to say his daughter was present for today's ceremony.

Vernon Hubert Jackson, 25, of Farmersville, U.S. Army, Sgt. Co. B, 9th Infantry, 2nd Inf. Div. Landed in Normandy

on D-Day+1. Wounded at the Battle of St. Lo about a month later, and died July 27, 1944, of wounds in France.

He is buried at the Princeton Cemetery.

Jerry Wayne Fraze, 21, of McKinney, U.S Marine Corps, Cpl. Fox Co. 2nd Bn. 4th Marines, 1st Marine Div. Wounded

in action December 11, 1967. Killed in action March 12, 1968, while leading a direct assault on a fortified bunker

complex in the small village of Lam Xuan, near the DMZ in Vietnam. He is buried at the Restland in Dallas.

Clark Gullette, MVPN Service Coordinator, took a moment to recognize R.D. Foster and Colin Kimball for the

work and effort put into these portraits. Mr. Kimball thanked Stacey Kemp, County Clerk, for her continuous

support by taking donations from the public for this cause. (Time: 11:15 a.m.)
