Proposed Budget

The Commissioners Court shall hold the proposed budget public hearing on a day within 10 calendar days after the date the proposed budget is filed but before the last day of the first month of the fiscal year. LGC 111.067(b)

The Commissioners Court shall publish notice that it will consider the proposed budget on the date of the budget hearing. The notice must include, in a type of a size at least equal to the type used for other items in the notice, any statement required to be included in the proposed budget under LGC 111.003(b). LGC 111.067(c) and (d).

A proposed budget that will require raising more revenue from property taxes than in the previous year must contain a cover page with the following statement in 18-point or larger type: "This budget will raise more total property taxes than last year's budget by (insert total dollar amount of increase and percentage increase), and of that amount (insert amount computed by multiplying the proposed tax rate by the value of new property added to the roll) is tax revenue to be raised from new property added to the tax roll this year." LGC 111.033(b)

At the conclusion of the public hearing, the commissioners court shall take action on the proposed budget. A vote to adopt the budget must be a record vote. LGC 111.068(a)

Tax Rate

The governing body of a taxing unit may not adopt a tax rate that exceeds the lower of the voter-approval tax rate or the no-new-revenue tax rate calculated as provided by this chapter until the governing body has held a public hearing on the proposed tax rate. **Tax Code 26.05 (d)**

The governing body of a taxing unit may not hold a public hearing on a proposed tax rate or a public meeting to adopt a tax rate until the 5th day after the date the chief appraiser of each appraisal district in which the taxing unit participates has delivered the notice required and complied with section 26.17(f)

The governing body may vote on the proposed tax rate at the public hearing. If the governing body does not vote on the proposed tax rate at the public hearing, the governing body shall announce at the public hearing the date, time and place of the meeting at which it will vote on the proposed tax rate. **Tax Code 26.**

A meeting to vote on the tax increase may not be held later than the 7th day after the date of the public hearing. The meeting must be held inside the boundaries of the taxing unit in a publicly owned building. Tax Code 26.

Adoption of the tax rate must not be later than the <u>71st</u> day before the November election date if the Commissioners Court wishes to adopt a tax rate that exceeds the voterapproval rate. **Tax Code 26.05(a)**

Deadline to order an election to be held on the November uniform election date is the 78th day before election day. Election Code 3.005(c)

Before the later of September 30 or the 60th day after the date the certified appraisal roll is received by the taxing unit, shall adopt a tax rate for the current tax year and shall notify the assessor for the unit of the rate adopted. **Tax Code 26.05(a)**
