

# LEGAL DESCRIPTION 3.3975 ACRES

**BEING** a tract of land situated in the Sarah D. Terry Survey, Abstract Number 890, City of Princeton, Collin County, Texas and being a portion of that tract of land conveyed to Boat Investments, LLC, according to the document filed of record in Document Number 20170626000832040, Deed Records Colin County, Texas, (D.R.C.C.T.) also being a portion of that tract of land conveyed to Lennar Homes of Texas Land & Construction, LTD, according to the document filed of record in Document Number 20181211001503350, (D.R.C.C.T.) said tract being more particularly described as follows:

**BEGINNING** at a 5/8" iron rod with plastic cap stamped "KHA" set in the west line of F.M. Highway 982, from which a 1/2" iron rod found in said line for a corner of said Boat Investments tract bears North 1°18'09" East, 430.69 feet;

**THENCE** South 1°18'09" West, a distance of 100.01 feet to a 5/8" iron rod with plastic cap stamped "KHA" set for a corner of this tract;

**THENCE** over and across said Lennar Homes and Boat Investment tracts the following fourty-one (41) courses and distances:

North 44°10'35" West, a distance of 28.05 feet to a 5/8" iron rod with plastic cap stamped "KHA" set for a corner of this tract:

With said curve to the left, an arc distance of 75.07 feet to a 5/8" iron rod with plastic cap stamped "KHA" set for a corner of this tract, at the beginning of a reverse curve to the right having a central angle of 19°41'58", a radius of 200.00 feet, a chord bearing and distance of South 76°49'17" West. 68.43 feet:


