Commissioner Hale said he has received multiple inquires and complaints on when the monthly free trash day will be reinstated and has invited Jon Kleinheksel, Public Works, to talk about what is happening with the program. Mr. Kleinheksel said the program began in October 2004 and was suspended in August 2018. It was intended for brush and bulky items and has since evolved into a majority of commercial dumping for contractors. Safety is now the main concern as this program has become unmanageable. TxDot (Texas Department of Transportation) updated the lanes outside the City Dump and by doing so removed the area where they staged and queued cars for the monthly dump. With the lanes now gone, the lines back up and create an unsafe amount of traffic. A citizen tried to cut the line and ended up hitting a Melissa PD (Police Department) patrol car. Melissa PD is already on site for this program, but moving forward they will have had to increase the amount of police presence due to the combativeness of some contractors and civilians trying to dump items not allowed. Mr. Kleinheksel has spoken with Public Waste for North Texas and they would prefer to eliminate the program. Commissioner Hale said that it comes down to safety issues and agrees that the program should end. Commissioner Fletcher agrees that it is time to end the program. With no further comments, a motion was made to approve this item. (Time: 1:40 p.m.)
