An order of the Commissioners Court approving the filing of the April 26, 2021 minutes.

On Monday, April 26, 2021, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Judge Hill led the Invocation.

Commissioner Webb the Pledge of Allegiance.

Commissioner Fletcher led the Pledge of Allegiance to the Texas Flag.

Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. and recessed the meeting at 2:02 p.m. The meeting was reconvened at 2:02 p.m. and immediately recessed into Executive Session. The Judge reconvened and adjourned the meeting at 3:08 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 2:02 p.m. and adjourned the meeting at 2:02 p.m.

2. Public Comments.

Miguel Gonzalez Palacios, Plano, expressed his concerns regarding the leadership and effectiveness of Commissioners Court. Mr. Palacios said he is angry that a citizen's remarks are being labeled as asinine and uninformed. Remarks are feedback on the Court's performance, and it would be best for the Court to understand where it is failing so it can improve. In the last three years, the Court has had three crises. On the COVID-19 crisis, a letter from the Court to Dr. John Hellerstedt, DSHS (Texas Department of State Health Services), referenced an operation plan with 25 cities within the County and, unfortunately, that plan is nowhere to be found. The second crisis was the ERCOT (Electric Reliability Council of Texas) power shortage, and the Court did not provide any guidance or presence. In times of crisis, leaders are physically present to inspire confidence, trust and a sense of control. The third crisis is the death of an inmate in the Collin County Sheriff's Office. Mr. Palacios said he will leave that topic for another time because it deserves three full minutes. Mr. Palacios asked for the Court to work with citizens to improve these situations.

Tamara Johnson, McKinney, brought to the Court's attention the justice served in Minneapolis for the death of George Floyd at the hands of the local police officer. Ms. Johnson read an excerpt from her daily morning bible reading. Ms. Johnson asked the Court if there will be justice for Marvin Scott III.

Scott Coleman, Wylie, thanked the local entities for their incredible work with the COVID-19 vaccination distribution. Thanks to their efforts, the County's vaccination rate is up to par with Texas averages. Who is responsible for these impressive efforts has come under public dispute during Commissioners Court meetings. Joshua Murray, a concerned Collin County resident, has made frequent appearances highlighting the contrast between the amazing local entities and the County Commissioners. Thanks to Mr. Murray's advocacy, we have come to understand the disorganization and the inaction the County Commissioners and Judge have led despite claiming credit for what local entities have done. The local entities were always on the forefront of the vaccination effort by organizing early, making a plan, and executing it. The County Commissioners never made a comprehensive vaccination plan. On February 8, 2021, the Commissioners Court voted unanimously to disengage from the vaccination signup effort by

suspending the waitlist despite the importance of these names to the local entities. Once the vaccination

waitlist was outsourced to local organizations, the process became unorganized, and it endangered the

lives of many County residents. Mr. Johnson thanked Joshua Murray for trying to make the government a better place and said his ideas and suggestions have not gotten the respect they deserve.

Elizabeth Michel, McKinney, told the Commissioners to get ready because it's coming. Ms. Michel asked

them to remember the pool party incident video and the outrage from the community. The video will be

released, and she hopes they are ready. Ms. Michel said she is aware the Commissioners don't have the

video, but they know who does. They also know how to contact them to put pressure on them. Ms. Michel

asked the Commissioners to demand the release of the video and the names of the Collin County eight.

There will continue to be peaceful protests at the Allen Outlet Mall, the Collin County Courthouse, the

Allen Event Center, McKinney Square, and the Byron Nelson Golf Tournament. Ms. Michel requested

more funding for mental health resources in Collin County. The Court should look further into the

CAHOOTS (Crisis Assistance Helping out on the Streets) Program in Oregon.

Joshua Murray, Lavon, thanked the city of Allen for their resiliency and unwillingness to quit. The Allen

Fire Department vaccine hub experienced a higher than expected volume of information gathering.

Unfortunately, their volume of work resulted in over utilizing city resources and specifically the city

dispatchers. While a less resilient government entity might have quit or suspended the gathering of

information, Allen worked with a third party to develop data entry robots to reduce the amount of workers needed by 70%. Mr. Murray said, if the Court decides to do an after action performance review, they could

contact Madison from the Allen IT department to look for some pointers. Mr. Murray asked if there are

any plans to utilize the County mobile COVID-19 vaccination clinics.

The most pressing matter is the responsibility of this Court to provide a safe and suitable jail. This Court

has an obligation to ensure the jail has the resources needed to accomplish their mission. This includes

compensation that allows the Sheriff to maintain and recruit a qualified work force. Mr. Murray asked if

the jail has enough clean blankets for all people in the jail awaiting trial, transfer, or release. The family of

Marvin Scott III was notified by text of his death more than a thousand hours ago. Local police

departments are releasing videos within 72 hours. (Time: 1:47 p.m.)

Commissioner Fletcher said the House has passed their budget, and it will go up to Conference Committee to reconcile differences between the House and the Senate. There is a list available of the differences in their budgets. The expansion of Medicare did not pass. The deadline for many bills is May 23, 2021. The redistricting deadline is September 30, 2021, and the primaries are expected to be pushed back. There will be a roundtable next month on the Recovery Act Funds. Commissioner Fletcher gave a brief review of bills pending at the 87th Legislative Session.

Commissioner Fletcher said she was involved in HB118 because it put the criminal justice grants at risk if the County did not have 100% compliance for all cyber security training. The Commissioner said she spoke with Senator Angela Paxton and explained the same goal can be accomplished by having a lockout provision as opposed to removing the grants. This provision would lockout anyone who has not completed the cyber security training. Ultimately, the change was made to HB118.

Commissioner Williams said the 1115 Waiver was pulled back and, as a result, much of the mental health funding will be lost. The Commissioner asked if there was any discussion about how the State will get some of the funding replaced. Commissioner Fletcher said this vote took place after their meeting but expects this to be a big point of discussion at the next meeting. Judge Hill said he hopes everyone in the community understands that, because the Biden administration removed the 1115 Waiver, Collin County is going to lose \$6 million for mental health services. (Time: 2:01 p.m.)
