Lolisa Laenger of the Collin County Historical Commission presented the new brochure to the Commissioners. Judge Self made a motion to accept the brochure, Commissioner Hoagland seconded, and it passed with a 5-0 vote of the Court. (Time 9:16 a.m.)

#### **COURT ORDER NO. 2007-032-01-09**

Item No. 6 Al-26023 Designation and ballot drawing of nine (9) public members (in lieu of nine elected officials) and four (4) alternate members from the 2006 Grand Jury members to be appointed and serve on the 2007 Salary Grievance Committee and any action, Commissioners Court. Names were drawn out of a box by the Commissioners and they were: Penelope Steele LeFlore, Isiah Joshua, Glen Renfro, David Alan Roper, Danny Lynn McKinzie, Ricardo Samuel Perez, Brandon Andrew Bartlett, Diane Tomlin, and Mary Beserra. Item No. 7 Al-25982 Discussion and any action regarding the proposed changes to the NTTA Governance Structure, Commissioners Court. Paul Wageman, Chairman of the Board of the North Texas Tollway Authority, NTTA, one of two Collin County representatives on the Board came before Commissioners Court. Gary Base, the other representative, was not feeling well and did not appear. Allen Rudder, Executive Director, appeared. These men

came at the Commissioners' request to discuss an ordinance change that the NTTA is pursuing. Mr. Wageman gave an overview of the NTTA and its Board Members. The ordinance change, proposed at the NTTA's December 2006 Board meeting, would eliminate the two rotating seats; Fannin County would get two permanent seats; and Tarrant County would immediately get a second board seat. New counties seeking admittance to the NTTA would be granted one seat upon admission and be required to have a current project. A second seat would be given to a county that has a project, but only after three years of operation and exceeding ten miles in length. Additional change to the governance would require an 85% vote by the Board for major decisions. These by-law changes were approved by acclamation at the December 2006 Board meeting and a legislative package is being prepared for adoption. Currently, the NTTA has received resolutions in support of these changes from Denton County and Tarrant County; Dallas County is considering the changes and has asked NTTA representatives to appear before their court. Commissioner Hatchell moved to approve NTTA's ordinance changes; Commissioner Jaynes seconded and the motion passed with a 4-0 vote of the Court (Commissioner Hoagland had stepped away from the dais and did not vote.) (Time: 10:10 a.m.)

Item No. 8 AI-26030 Consideration, discussion and any action regarding Payment of 1985 Compensatory Time, Human Resources. Cynthia Jacobson, Human Resources Director, explained that with the Peoplesoft software conversion, it was brought to Human Resources attention that several County employees still have comp time left over from as far back as 1985. The question was whether to carry it over into Peoplesoft or go ahead and pay it out but at what rate, 1985 dollars or the current rate. Commissioner Hoagland made the motion to go ahead and pay this comp time and at the 1985 rate since it was acquired in 1985; Commissioner Cole seconded, and the motion passed with a 3-2 vote of the Court. Commissioner Hatchell and Commissioner Jaynes voted no. (Time: 9:20 a.m.)

John Roach, District Attorney, gave a detailed presentation to the Court concerning the creation of a civil division being developed through the District Attorney's office; he went over the advantages and disadvantages, he covered history and made Mr. Roach covered funding, projections based on the size of our county. staffing, special issues that would require outside counsel, how it would grow, specifics on how it could be utilized, and he stressed that the timing is right for Rodney Rhoades handed out documentation to such an entity to be created. the Court showing past expenditures on civil cases. Commissioner Jaynes suggested leaving this issue till the formal budget discussions in the future. Commissioner Cole wanted more discussion and interaction. Commissioner Hoagland wanted to move ahead with DA Roach's suggestion, 'strike while the iron is hot and there are good available personnel to hire'. Commissioner Jaynes motioned to continue the discussion with more study on the issue; Commissioner Cole seconded asking for more clarification on the presentation; and the motion passed with a 5-0 vote of the Court. Judge Self expressed the need for off-cycle, open meetings for county residents in order to have the opportunity to listen to the Commissioners discuss the various issues. Commissioner Cole concurred and gave some information on Dallas County's approach. Commissioner Jaynes also expressed his support, saying that being able to talk about the issues without being under the constraints of the formal Court meeting would be good and would help in better decision making. Bill Bilyeu, Adminstrative Services, clarified that a detailed agenda still has to be prepared even without formal voting; when you have a meeting, notification has to be posted 72 hours continuously prior to the meeting, or workshop. Regularly scheduled Commissioners Court meetings will continue on Tuesdays; Commissioner Jaynes stressed the need to discuss holding some Court sessions at other times for better public access; and Commissioner Hoagland noted holding Court at different locales would also be in the public interest. Unless there is a personal reason to keep discussions confidential, they should be discussed in open session. Commissioner Hatchell made the motion to move as much as possible to open court sessions, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time: 10:39:36.)

The Court specifically discussed Michelle Patrick's assignments, how her time has been used, and how it will be used. Bill Bilyeu and Rodney Rhoades, Budget, both gave clarification and explanation. Candy Blair, Healthcare Services, also spoke about Michelle Patrick's help in grant writing. Item No. 15 Al-26027 Presentation, discussion and any action regarding proposed new District Courts, District Courts. Dale Rose, currently the President Elect of the Collin County Bar Association (has served as Secretary and Director of the same organization) stood before Commissioners Court. Mr. Rose presented information about the Collin County Bar Association. As representative of the attorneys involved in that association, he appeared before Commissioners Court in support of Judge Henderson and his presentation concerning the creation of two new district courts. Judge Curt Henderson, 219<sup>th</sup> District Court, came to ask the Commissioners to champion the cause for the creation of two new district courts. Judge Henderson stressed that the creation of only one new court would be a mere lifeline; that two new courts is what would bring some relief. Judge Henderson gave a presentation looking at juvenile, criminal and civil case filings; how they have grown through the years; and the

process cases go through before actually being assigned to a court. county's growth rate, without the second court to handle the growing caseload, Judge Henderson explained that temporary injunctions would be first, criminal cases second, and civil would go to the bottom of the pile and not have a hope of being assigned in terms of months but rather years. Judge Henderson stressed that these cases represented real people, with a right to come to the courthouse to receive a peaceful resolution to their case in a speedier manner than what will Judge Henderson is specifically asking for a new district court by occur. September of 2007 and a second by September 2008. The Commissioners asked District Attorney Roach about staffing issues. The Commissioners then asked Judge Henderson about specialized courts/dockets. There was discussion among the Commissioners about population growth, waiting for the State Legislature to appoint a new court based on that population, the costs and where that money would come from, the public and their feeling of need for the second court. Bill Bilyeu, Administrative Services, addressed the issue of when the Governor steps in mandate creation a new court. Judge Henderson stressed that if the second district court isn't created, there will be a reduction in services. Judge Self noted hearing from attorneys and judges, but what about the citizens. Commissioner Jaynes stated that the citizens were heard when voting to support the building of the new District Courts Building. Commissioner Hoadland noted that Collin County had, in the recent past, tried to anticipate needs and be proactive, although a bit behind the curve at times. Commissioner Hoagland suggested the installation of a new district court October 2007 and letting the Legislature appoint one in early 2009. Judge Henderson stressed that he can support that, but would like the Commissioners enthusiasm in support as they petition Austin. Commissioner Hoagland made a motion that they ask the Legislature to approve one new district court in September 2007 and then appoint a second one in January 2009 (one elected and one appointed,; Commissioner Hatchell seconded, and the motion passed with a 4-0 vote of the Court. Judge Self was the dissenting vote, but he expressed a desire to further discuss the issue with Judge Henderson. (Time: 12:19:10 p.m.)
