<u>Item No. 1</u> Judge Self convened the <u>Collin County Commissioners Court</u> meeting to order at 9:02 a.m. and adjourned at 1:58 p.m.

Caren Skipworth, Director of Information Technology, noted that the computer room would not be moving until December 2007, and she added the concern that the current air conditioning unit had flooded the room several times. Ms. Skipworth's preference is to shut it down and go with the temporary choice to cool the room. Ms. Skipworth also noted that time is of the essence. Commissioner Hatchel motioned

Commissioner Hatchell wanted to know if the County could terminate this contract at any time, his concern being the County's expense incurred if someone else could eventually get control of the road project. Ruben Delgado, Director of Engineering, said he would be attending a meeting about it during the week. Commissioner Jaynes questioned if Jeff Durham, Special Projects, could handle the right-of-way acquisitions in-house; he then had questions for Mr. Delgado who went over the situation at length, the people involved, the costs, and the possible length of completion time. Commissioner Hoagland felt that hiring the proposed company would be preferable to letting it drag on, but he wanted to know what MACTEC would do to earn the County's money. Ruben Delgado said that this section being discussed was the 'keystone' to the whole project and that the County would accept the challenge in obtaining this right-of-way. Mr. Delgado stated that even with the experience between himself and Jeff Durham's office, MACTEC would be doing a lot of the legwork; but if the Court preferred to keep it all inhouse, he would be prepared to do that. Mr. Delgado entertained questions from the Court and said that he would keep the Court Commissioner Hoagland asked for specifics on what informed. MACTEC would do for their payment. Mr. Delgado said they would familiarize themselves with the project, review title, review appraisals, deliver contracts and negotiate with the land owners, make presentations to the Commissioners on same, take the offers to the land owners and if accepted, close the contracts. Jeff Durham, Special Projects, and Bob Brown of TxDot. Texas Department of Transportation, both answered questions and addressed the Court from the audience giving more details on the subject. Commissioner Jaynes motioned to go ahead and approve this contract, Commissioner Hoagland seconded. and the motion passed with a 5-0 vote of the Court. John Kleinhexsel, Director of Public Works, addressed the Court. There is a residential request for a stop sign. Commissioner Hoagland made a motion to accept, Commissioner Cole seconded, and the motion passed with a 5-0 vote of the Court. Commissioner Jaynes complimented Mr. Kleinhexsel on his handling of all the new signage with so much construction in the County. (Time: 9:41:49 a.m.)

Commissioner Hoagland explained that all members of Commissioners Court would be official members of the Task Force as well as Judge C. Henderson, District Attorney John Roach, Judge Greg Brewer, and Judge Oldner; others would be brought in as needed. The purpose of the Task Force would be to streamline the process and save money. No County Courts are involved at this time; the focus will be on District Courts for now Commissioner Jaynes made a motion to accept these members, Commissioner Hatchell seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:52:44 a.m.)

### **COURT ORDER NO. 2007-085-23**

Item No. 8 Al-26092 Consideration, discussion and any action regarding application to the Texas Department of Transportation (TxDOT) on Pass-Through Projects and concession payments from SH 121 for US 75 and Pass-Through Program, Commissioners Court. Commissioner Jaynes asked that this item be discussed today; he went over his insights into this and he asked Ruben Delgado, Engineering, to speak to the issue. Mr. Delgado introduced Tom Diamond, HNTB Corporation, and Bob Brown, TxDot, who gave a presentation to the Court. They covered the priority projects, the costs, and timeline saying a formal application needs to be made to TxDot and it moves ahead from there. Commissioner Cole asked for clarification on the money aspect; there would be payment up front with partial reimbursement later. Judge Self suggested narrowing the focus on this request to the TxDot portion and moving ahead. There was some further clarification from Ruben Delgado and more questions answered. Commissioner Jaynes made the motion to narrow the focus, Commissioner Hoagland seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:54:22 a.m.)

### **COURT ORDER NO. 2007-086-23**

Item No. 9 Al-26029 Discussion and any action regarding legislative items for the upcoming 80th Legislative Session, Commissioners Court. Judge Self went over House Bill 272, indigent health care proposed legislation. Commissioner Cole said it is Robin Hood health care and this bill needs to be diligently fought. Commissioner Hoagland suggested lobbying surrounding counties to work with Collin County as it would probably be a Collin County led effort. Judge Self suggested putting together a simple motion to formalize a statement for the next court. Commissioner Hatchell agreed and so motioned, Commissioner Cole seconded and made an amendment for Judge Self to immediately draft and send a letter to judges of all non-hospital district counties in the State of Texas and then make a resolution, and the motion passed with a 5-0 vote of the Court. (Time: 10:16:13 a.m.)

"Any statutory county court judge in Collin County may hear and determine a matter pending in the Collin County Statutory Probate Court, regardless of whether the matter is preliminary, final or whether there is a judgment in the matter."

Commissioner Hoagland motioned to accept the amended language, Commissioner Hatchell seconded, and the vote passed with a 5-0 vote of the Court. (Time: 10.29:56 a.m.)

**COURT ORDER NO. 2007-088-23** 

Discussion and any action regarding the creation of a Civil Section in the Item No. 10 Al-26080 District Attorney's Office, District Attorney. District Attorney John Roach came before the Court and reviewed what he had presented at the previous Court concerning the start of a civil division in his office. He went over information he had been asked to gather, present and interpret. Bond Council cases, and delinquent tax cases are the only ones he found that would not be handled in a Civil Division; they are too specialized. Mr. Roach spoke to the costs which would include personnel, offices, equipment, and supplies for the first year. Mr. Roach stressed that he feels the time is perfect, with certain key people currently available to hire, and with the growth of the county. Commissioner Jaynes and Commissioner Cole expressed the opinion that things are going fine as they are, and they also stressed that they think the current costs are very reasonable. Commissioner Hatchell said he did not want to go ahead with two attorneys, he could support one; possibly hire another attorney in six months or so. Commissioner Hoagland pointed out that the County District Attorney has had the authority to move ahead with such a request by law and Commissioner Hoagland said he thinks it would be good to move ahead on this motion at this time. Judge Self was concerned about the 'fire wall' protection between the Commissioners Court and the District Attorney's criminal duties; in other words, can you be a watchdog for, and keep an eye on, the Court itself. District Attorney Roach stressed that there is no conflict in being that watchdog because he answers to the voters of Collin County. Commissioner Cole also expressed her concern because of the fact that a larger part of the County's need for an attorney comes because of personnel situations. Mr. Roach read the current description of his official duties and authority toward the County; he stressed that this new civil division would provide an attorney for the Commissioners Court. Commissioner Hoagland noted that the district attorney has always had the power to have this sort of division; the district attorney's office had just never exercised the right. And clarification was made by Judge Self, and Mr. Roach, stating that the district attorney has the authority of a criminal district attorney and civil attorney by statutory law. Judge Self lent his support for creating this civil division. Commissioner Hoagland motioned approval for District Attorney Roach's creating a civil division with one attorney, Commissioner Hatchell seconded, and then further discussion happened as Sheriff Box asked about specific use of this new division and Commissioner Hatchell and Commissioner Jaynes stressed that it needed to be discussed in a workshop scenario, the first being February 5. Commissioner Hatchell withdrew his second on Commissioner Hoagland's motion, and then motioned to move this action into the workshop session. Commissioner Hoagland seconded, and the motion passed with a 4-1 vote of the Court. Commissioner Jaynes voted no. (Time: 10:32:47 a.m.)
